#### Notification for admission to Post Graduate Courses for the academic session 2025-27

Re-Advertisement for Admission procedure to the first semester of following PG Courses for the academic session 2025-2027 will start from **25/09/2025**. Govt. Notification No.986-Edn(U)/HED-12016(21)/5/2025-UNV SEC-Dept. of HE, dated 01/08/2025 issued by the University Branch, Department of Higher Education, Government of West Bengal, Admission Notification, Schedule and the Guidelines will be strictly followed during the admission procedure.

Online applications are invited from eligible Candidates who are Honours Graduates of both CBCS and (1+1+1) pattern, who passed out during 2023, 2024, and 2025, and Graduates of Programme Courses under CBCS, passing in the years 2023, 2024, and 2025 only, for admission to the following regular full-time PG courses (duration: 2 years or 4 semesters) for the academic session 2025–2027. A few seats are available in subject-specific Post Graduate courses such as Biotechnology, Business Administration (M.B.A.), Commerce, Computer Science, Economics, Environmental Science, Integrated B.Lib.I.Sc. – M.Lib.I.Sc. , Journalism and Mass Communication, Law (LL.M.), Mathematics, Performing Arts (Music – Vocal – Hindustani), Performing Arts (Music – Vocal – Rabindra Sangeet), Physics, Psychology, Master of Sports Science , English in J.K. College , History in J.K. College and Mathematics in J.K. College as the first preference.

- Note For the Self-Financing courses like Masters in Biotechnology, Business Administration (M.B.A.), Computer Science, Environmental Science, Integrated B.Lib.I.Sc. M.Lib.I.Sc. , Journalism and Mass Communication, Law (LL.M.), Performing Arts (Music- Vocal- Hindustani), Performing Arts (Music- Vocal- Rabindra Sangeet) and Master of Sports Science, there is no restriction on year of passing of UG course, A candidate having requisite qualification are eligible to apply for admission to the Self-Financing courses irrespective of the year of passing the qualifying examination.
- Only completed online applications will be considered. All notifications and lists will be published in the University website <a href="www.skbu.ac.in">www.skbu.ac.in</a> as well as in SKBU PG Admission portal i.e., <a href="https://pg.skbu.ac.in">https://pg.skbu.ac.in</a>
- Normally a candidate is eligible to apply for maximum three courses. However, a candidate already applied for/admitted in the general PG course may also apply for the Self-Financing courses. In such case there shall be no bar for application for more than three subjects. Please note a student will be permitted to pursue only one course in the same academic year.

#### > Eligibility:

- (i) **80% seats** are allocated for the Honours Graduates of Home University who completed 03-year Honours Course in relevant subject and passed in the years **2023**, **2024** & **2025**.
- (ii) 20% seats will be for the:
  - (a) Honours Graduates of Other Universities with 03-year Honours / major in relevant subject who have completed their graduation in the years **2023**, **2024** & **2025**.
  - (b) The Programme Course students passed in 2023, 2024 and 2025 with at least 60% in aggregate are eligible to apply for PG course in his / her Discipline 1.
  - (c) Students of SKBU who did not get chance of admission in 80% category are also eligible to be considered in 20% category.
  - Note: There will be no distribution of 80% and 20% seats for Master in Laws (L.L.M.)
  - M.Sc. in Biotechnology: Bachelor Degree in Life Science (B.Sc.)/ 3-year Honours Graduates in Agriculture, Animal Science, Botany, Biotechnology, Bio-Chemistry, Genetics, Life Science, Microbiology, Molecular Biology, Physiology, Zoology and other allied subjects or Programme Graduates (CBCS) having any of the above-mentioned subjects as Discipline 1 are eligible to apply.
  - Master of Business Administration (M.B.A.): (i) 3-year Honours Graduates / Programme Graduates (CBCS) in any discipline or (ii) Bachelor Degree (under 10+2+4 system) in Engineering and Technology/ Medical Science/ Law/ Professional Courses or its equivalent from any recognised University or (iii) Bachelor Degree (under 10+2+3 system) in Business Administration (BBA) are eligible to apply.
  - M.Sc. in Computer Science: 3-year graduates with (i) B.Sc. (Honours) in Computer Science or (ii) BCA or (iii) B.Sc. Honours in Mathematics/ Statistics/ Physics with Computer Science as one of the pass subjects or (iv) B.Sc. Programme with Computer Science and Mathematics/Physics/Statistics are eligible to apply.
  - **M.A in Economics:** 3-year Honours Graduates in Economics, Mathematics & Statistics **or** Programme Graduates (CBCS) having any of the above-mentioned subjects as Discipline 1 are eligible to apply.
  - M.Sc. in Environmental Science: 3-year Honours Graduates in Environmental Science, Botany, Chemistry, Geography (Sc), Geology, Microbiology, Biotechnology, Zoology, Nutrition, Physiology, Agriculture, B.Tech./B.E. in Civil /Mechanical or Programme Graduates (CBCS) having any of the above-mentioned subjects as Discipline 1 are eligible to apply.
  - Integrated B.Lib.I.Sc.–M.Lib.I.Sc.: Applicants having (i) Bachelor of Library and Information Science (BLISc) or (ii) B.A./B.Sc./B.Com. or (iii) MBBS/ BDS or (iv) LLB or (v) PG/ Master degree in any discipline, are eligible to apply.

- M.A. in Journalism & Mass Communication: 3-year Honours Graduates / Programme Graduates (CBCS) in any discipline are eligible to apply.
- Master of Laws (L.L.M.): LL.B. (3-year or 5-year integrated course) are eligible to apply.
- Master of Performing Arts (Music: Vocal –Hindustani): (i) 3-year Honours Graduates in Music or (ii) Programme Graduates (CBCS) having Music as Discipline 1 or (iii) Graduates (3-year) in any stream with Diploma in Music from recognized University / reputed Institute or (iv) Graduates (3-year) in any stream from recognized University or Institute with special aptitude in Music, are eligible to apply.
- Master of Performing Arts (Music: Vocal –Rabindra Sangeet): (i) 3-year Honours Graduates in Music or (ii) Programme Graduates (CBCS) having Music in Discipline 1 or (iii) Graduates (3-year) in any stream with Diploma in Music from recognised University / reputed Institute or (iv) Graduates (3-year) in any stream from recognized University or Institute with special aptitude in Music, are eligible to apply.

- <u>Note:</u> M.Sc. in Mathematics, M.A. in English and M.A. in History are also taught in J.K. College, Purulia and M.A. in Bengali in Nistarini College, Purulia on self-financing basis, and admission will be made through the central counseling by the University.
- Mode of Payment for admission is only online through Payment Gateway given in the admission portal by Debit/Credit card and Net Banking. No Fees will be accepted in any other form. Candidates need not come to the University counter for any payment.

## **Selection Process/ Process of Merit list framing:**

- (i) For the Honours/ Programme Course (CBCS) students only passing years **2023**, **2024** & **2025** except Self -Financing Courses will be considered.
- (ii) The candidates of the Programme course securing minimum 60% marks will be eligible to apply for PG course of study in 1<sup>st</sup> Discipline only.
- (iii) For the Honours Candidate of (1+1+1) pattern, **Percentage of Marks obtained in Honours** subject will be considered.
- (iv) Both for the Honours and Programme course candidates of CBCS curriculum, the secured CGPA will be considered.
- (v) CGPA will be converted to percentage by multiplying it by 10 for the students of SKBU. For other Universities instructions given in the Grade Card by the Universities will be followed for conversion of CGPA to percentage and if no instruction/formula is available, the standard procedure will be adopted and if Aggregate Percentage is available in addition to CGPA then that percentage will be considered.
- (vi) There will be no Entrance Test.
- (vii) **80% Category:** Selection will be made strictly in order of merit by taking into the consideration of **Aggregate Percentage** of the Marks secured in Graduation only.
- (viii) **20% Category:** Selection will be made in order of merit by taking into the consideration of **Aggregate Percentage** of the Marks secured in Graduation only.

#### • In case of tie, following procedures will be considered to resolve it in sequential order.

- a) The marks (percentage of best four subjects) of HS (10+2) will be considered.
- b) If again tie occurs, then the aggregate percentage (%) of Madhyamik (10<sup>th</sup> level) marks will be considered.
- c) If still tie remains Aggregate Percentage of 1<sup>st</sup> and 2<sup>nd</sup> Language subjects obtained in HS (10+2) will be considered.
- <u>Note:</u> (i) During filling up the Form for admission, if any candidate applies for admission in Nistarini College or JK College as the first preference and if get admitted in the said college, afterwards he/she will not be upgraded for admission to SKBU even when seats fall vacant in SKBU.
  - (ii) Any candidate, if applies for admission in SKBU as the first preference, but got admission in Nistarini College or JK College, in later period the candidate may be upgraded to SKBU after fulfillment of all terms and conditions.

- Reservation for UR DAP has been given from the UR seats after distribution to SC, ST, OBC-A & OBC-B categories. If candidates of UR DAP are not available, the seats will be converted back to UR category.
- Reservation for SC DAP has been given from allotted seats of SC category where the 5% figure is 0.5 or above. If candidates of SC DAP are not available, the seats will be converted back to SC category.

All necessary documents must be in readable form those are to be uploaded online during submission of Application Form.

- **ID card:** Issued by Govt. authority.
- **Proof of Age:** Admit or Certificate of Madhyamik or equivalent examination.
- **Proof of Marks:** All Undergraduate Mark-sheets/ Grade Cards, Mark sheet of HS/or equivalent examination (10+2) and Mark sheet of Madhyamik /or equivalent examination of 10<sup>th</sup> level.
- Certificate of Reserved category (if applicable): SC/ST/OBC-A/OBC-B certificate issued by competent Govt. authority.
- Certificate of EWS (if applicable): certificate issued by competent Govt. authority. EWS certificate is valid for the financial year of issuance of certificate.
- **Person with Disability Certificate (if applicable):** PWD certificate issued by competent Govt. authority.
- Meritorious Sports Persons: Certificates (only State-level position holder and National-level participant certificate issued by competent authority will be considered).
- ➤ <u>Verification of Documents:</u> Verification of all original documents will be made available at the time of commencement of 1<sup>st</sup> semester classes. If any candidate fails to produce her/his all original documents at the time of verification, her/his candidature will be cancelled. All originals and one set of self-attested photocopies of the above-mentioned **Documents** are required to be produced at the time of verification.

#### Few Important Modalities of Admission Process: -

- The admission process will be entirely online and according to merit. Merit list will be published only on the basis of result of qualifying examinations. The process will start on the basis of Notification issued by the Department of Higher Education, Govt. of West Bengal. On the basis of Data abstracted from successful applicants, provisional merit list and all merit list will be published in specified date and admission will be made according to merit list. Prospective students will not be called for counselling or verification of documents during admission process. No physical presence of Applicants will be required at the University during the process of admission or for any admission related issues until further directive is issued in this regard from competent authority.
- The candidates eligible for admission will be informed directly in a suitable way through **messages** (SMS) in the given **Mobile/Cell number/ email of the applicant**, University Website and PG Admission Portal by the authority.
- Admission Regulation of the University and Reservation policy as per Government rules will be followed.
- Payment of fees should be done only through e-payment or designated banks and should not be deposited physically at the University.
- All testimonials (must be in readable form) are required to be uploaded online during application.
   Verification of documents will be done only when the students report for the classes in due course of time. Admission will be cancelled if the documents are found not in conformity with the declaration in the forms submitted online. Proper legal action will be taken if any discrepancy is found.

- All PG courses at SKBU are full-time regular courses. In service candidates are not allowed to pursue the courses.
- The admitted students are required to maintain 75% attendance positively throughout all the semesters. If any student is found with attendance below 50% at the end of first 15 teaching days, his/her admission is liable to be cancelled.
- As per the UGC D. O. No 1-152029 (ARC) pt III, dated 24th May, 2023 and as per the Judgment of
