Online applications are invited from the eligible candidates for admission to M.V.Sc. & Ph.D Programmes of this University through SKUAST-J CET (M.V.Sc and Ph.D)-2025 for the academic year 2025-26.

Eligibility Requirements (M.V.Sc.)

- Candidates having a Domicile certificate of Union Territories of J&K and Ladakh are eligible for seeking admission in postgraduate programmes.
- The candidates hailing from states/UTs other than Jammu and Kashmir can seek admission under Self Financing, seats for Postgraduate courses kept under All India basis category only.
- For postgraduate programmes, candidates not below 19 years of age, as on 31-12-2025, are eligible to appear in the examination. No relaxation is admissible regarding the minimum age limit.
- The candidate must have passed or due to appear at the final examination and likely to get awarded the degree **on or before the counselling date as mentioned** in the brochure to be eligible for admission to postgraduate programme.
- **Admission guidelines for in-service candidates of SKUAST-J Employees and UT Govt. Nominee:**
 - i. For admission of SKUAST-J In-Service Employees' and In-service UT Govt. Nominee, only those applications with the prior permission from their employer shall be entertained.
 - ii. All Such candidates have to appear in SKUAST-J CET-2025.
 - iii. The admission to such candidates shall be granted only after the submission of the "permission letter of their employer" at the time of counselling.
- The candidates must have passed B.V.Sc. & A.H degree examination securing Grade point average (OGPA) at least:
 - (a) **General category:** 6.00/10.00 on ten point scale, 3.00/ 4.00 on four point scale. In other cases where grade point are not awarded and only marks are awarded, the candidate must have secured at least 60% marks.
 - (b) **Reserved categories:** 5.50/10.00 on ten-point scale or at least 55% marks where grade point is not awarded.

M.V.Sc. Counselling:

Qualified candidates, as per merit, shall be called for counseling on a specified date and time for consideration of admission. There will be three rounds of counseling followed by a mop-up round, if required. The merit list will be uploaded on the university website (www.skuast.org). The candidates are advised to see regularly the website of the University for counseling dates. No separate letter will be sent to the candidates. The counseling schedule will be notified in the newspapers as well as on the University website.

Eligibility requirement (Ph.D. Programme):

- i) Master's degree in respective/related subjects.
 - ii) 6.50/10.00 or equivalent OGPA/equivalent percentage (65%) of marks at Master's Degree for General Category candidates.
 - iii) 6.00/10.00 or equivalent OGPA/equivalent percentage (60%) of marks at Master's Degree for SC/ST/PH category candidates.
- For Ph.D programme in Microbiology, the eligibility shall be M.Sc. (Ag) Microbiology /M.Sc. Microbiology /Biotechnology/Environmental Science/Molecular Biology and

Biotechnology /Life Sciences /Plant Pathology (with specialization in Microbiology)/Soil Microbiology.

- Candidate must have passed or due to appear in the final examination and likely to get awarded the degree on or before the date of counselling.

A. Written:	
(i.) MCQ—subject specified	=70 Marks
(ii.) MCQ—Research Methodology	=10 Marks
B. Interview:	=20 Marks
Total	100 Marks
Minimum remarks required for admission to Ph.D Programme= 50 % (Written + Interview)	

Note: Interview shall be held immediately after the written test.

Admission:

Selection for admission shall be made on the basis marks obtained in SKUAST-J CET (Ph. D.) 2025. In case there is tie in the marks of SKUAST-J CET (Ph.D) candidates having higher overall marks at the Master's level would be placed higher in the rank. However, if marks obtained are again tie, the candidate having higher overall marks at graduation level would be placed higher in the rank.

General Instructions:

- i. The candidates seeking admission to SKUAST-J common entrance test are advised to:
 - go through the information brochure carefully and acquaint themselves with all the requirements, rules and regulations.
 - satisfy themselves about the eligibility criteria prescribed for appearing in the entrance examination.
 - strictly adhere to the last date of submission of application form.
 - write complete address with Postal Pin Code, Telephone No., Mobile No., e-mail address, in the application form.
- ii. Candidates in employment should apply through proper channel and shall have to produce No Objection Certificate of the employer before submitting the online application form.
- iii. The University may cancel the admission of a candidate in the event of suppression of facts or if the admission was made erroneously.
- iv. Incomplete application/application(s) received beyond the last date shall be summarily rejected.
- v. For in-service teachers of SKUAST-J, there is one supernumerary seat in each division. However, they have to apply for admission in pursuance to this advertisement and should qualify the examination as envisaged in the brochure. They must possess "No Objection certificate" of the employer before submitting the online application form.
- vi. Admission of employees other than the teachers in SKUAST-J, who do not fulfil the conditions under FIP, shall be consider as per J&KCSR norms. But, they have to earn seat through prescribed norms of SKUAST-J CET (Ph.D.) after seeking prior permission from the employer.
- vii. Teachers/other than Teachers who do not qualify w.r.t. the length of service as elucidated SKUAST-J Statutes/J&KCSR can be considered for deputation to pursue Ph.D. without salary. But they have to earn the seat through prescribed norms of SKUAST-J CET (Ph.D.) 2025 after seeking prior permission from the employer.
- viii. Candidates should have completed their Master's Degree.
- ix. Merely submission of the application/appearing in the CET does not give entitlement of the

admission in concerned discipline; the admission is subject to merit attained & availability of the seat in concerned discipline besides fulfilling all the requirements as envisaged in Regulations of Resident Instructions of SKUAST-J.

- x. INSPIRE, GATE, SRF and other fellowship holders are exempted for appearing in CET -2025 and would be admitted against supernumerary seat up to the extent of 01 in each discipline in case there are more than one candidate under this category in a stream, the merit obtained at the Master's level degree shall be considered for selection. However, they have to apply for admission in pursuance to this advertisement.
