

# Dr. NTR UNIVERSITY OF HEALTH SCIENCES: ANDHRA PRADESH: VJA – 8

Notification for exercising web options for 1st Phase of web based counseling for admission into M.Sc(N) Courses for the academic year 2025-26.

In continuation of earlier notification dated 16.10.2025 Dr. NTR UHS, Vijayawada hereby notifies the schedule for exercising Phase-1 of web based counselling for PG i.e., M.Sc(N) courses for admissions under Competent Authority Quota (CQ) for the academic year 2025-26 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Final Merit list notified in the website on 24.11.2025 are only eligible to exercise their web options as per the seat matrix displayed on the website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a>

The process of admission into the said courses will be in accordance with the orders issued by Govt. of A.P. as follows:

#### M.Sc(N):

- a. G.O.Ms.No.338, HM & FW (K2) Dept., dt.16.09.2008,
- b. G.O.Ms. No.33, HM & FW (C2) Dept., dt.18.02.2020, and other Govt. orders as applicable to PG Medical and Dental courses.

<u>UNIVERSITY FEE:</u> Candidates who are allotted with a seat, have to pay Rs.12,900/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

**TUTION FEE: 1. Govt. Colleges:** As fixed by the Government of Andhra Pradesh.

**2. Private Unaided Non-Minority Nursing Colleges:** As fixed by the Government of Andhra Pradesh

### Instructions to Candidates:

- 1. Area wise Seat Matrix is displayed in the University Website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a> for information of the students. All the eligible candidates present in the Final Merit list displayed on <a href="https://drntr.uhsap.in">24.11.2025</a> are eligible to opt for Phase-I counselling.
- 2. Candidates opting for M.Sc(N) courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges available.
- 3. Male candidates will be allotted seats in the colleges given consent to admit male candidates.

- 4. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are genuinely interested. If they are not interested to join any speciality or college then they are advised not to exercise options for the same.
- 5. The selected candidates have to login and to pay the University fee of ₹.12,900/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking) and report to the Principal of the Allotted College on or before the date specified in the allotment letter. University fee once paid is not refundable under any circumstances.
- 6. The selected candidates shall produce all the Original certificates, pay the Tuition fee, furnish necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
- 7. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS during subsequent Phases of counsellings, the original certificates will be sent to the college concerned after the closure of admissions.
- Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the website:
  M.Sc(N) Course\_- <a href="https://apuhs-pgadmissions.aptonline.in/pgmsccq">https://apuhs-pgadmissions.aptonline.in/pgmsccq</a> for status of allotment.
- 9. The candidates who secured admission in the Phase-I of counselling and wish to change their college/course according to their merit, can exercise their web options for Phase-II. Candidates informed that once M.Sc(N) seat is allotted in next counselling as per their web options, the seat allotted in the earlier counselling gets automatically cancelled and will be Re-allotted to other candidates as per Rules.
- 10. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- 11. Next Phase of counselling (exercising web options) will be conducted for:
  - a. Unfilled seats in Phase-I.
  - b. Not reported/Not joined seats of phase-I.
- 12. The University fee once paid shall not be refunded under any circumstances.

## Eligibility for Phase-II

- a) Fresh options will be obtained from all the eligible candidates for Phase-II/ Final Phase of counselling.
- b) Candidates who have not been allotted any seat in Phase-1 counselling.
- c) Reported Phase-I candidate can upgrade from Phase-I to Phase-II/Final Phase of Counselling Candidates getting upgraded in Phase-II shall not have any claim on Phase-I seat.

- d) Candidates allotted seat in M.Sc(N) courses under Competent Authority Counsellings of Phase-I or Phase-II/ Final Phase Counselling, are not eligible in MOP-UP round of counselling.
- e) Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules.
- f) Candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
- g) Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- h) Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II/Final Phase Counselling.
- 13. The University fee once paid shall not be refunded under any circumstances.
