CIRCULAR

It is for the information of all concerned that CSK Himachal Pradesh Krishi Vishwavidyalaya, Palampur has framed the following Rules and Guidelines for Migration of students of B.V.Sc. & A.H. degree programme from other colleges to B.V.Sc. & A.H. programme of CSKHPKV, Palampur for the Academic year 2026-27:

1. VCI regulations for the migration as per MSVE-2016 adopted by the CSKHPKV, Palampur - are as under:

Migration or Transfer of Student :-

- i. Student studying in a recognized Veterinary college which is included in the First Schedule of the Act may be allowed to migrate or be transferred to another recognized Veterinary college under another or same University.
 - ii. The migration or transfer may be allowed by the University concerned after passing 1st year of Bachelor of Veterinary Science and Animal Husbandry degree course within one month of the start of Academic Session of 2nd year of the receiving College or University.
 - iii. The number of students migrating or transferring from one Veterinary College to another Veterinary College during the period of one academic year will be kept to the maximum limit of 5% of the intake capacity of each of the Veterinary Colleges in one year.
2. The total number of seat available for migrating students will be **Four** (5% of intake capacity of 75 seats). In case of more than four applications for migration, the admission will be done strictly on merit basis as per University rules.
 3. The application complete in all respect must reach to the Registrar, CSKHPKV, Palampur by **28th September, 2026**. The University will not be responsible for any postal or other delay. Application must have following documents attached failing which it will not be considered for migration:
 - i. Application fee of Rs. 20,000/- (Non-refundable) in the shape of Demand Draft in favour of the Comptroller, CSKHPKV, Palampur for processing of application.
 - ii. No objection certificate from the Registrar of present Institute of the applicant, with the clear mention of the category (Non Self-Financing, Self-Financing/ Paid, etc.) in which he/ she got admitted in that Institute.
 - iii. Marks sheet of First Professional Year passed by the applicant.
 4. The list of selected candidates will be notified on **30th September, 2026** and will be available on the University Website i.e. <https://www.hillagric.ac.in>. The candidate of Self-Financing/ Paid seat category will be considered in SFS category of admission for all the purposes.
 5. The selected candidates shall have to register latest by **03rd October, 2026 (04.00 PM)** and deposit the requisite fee along with the Migration Fee of Rs. 50,000/-.
