The Heads of Institutions under this University are already aware of the UGC (Recognition and grant of Equivalence to Qualification obtained from Foreign Educational Institutions) Regulations, 2025 notified by UGC on 4-4-2025. However, still few institutions are forwarding the requests of candidates who obtained the entry level qualification from Foreign Educational Institutions without UGC Equivalence Certificate.

Hence, it is hereby informed to submit the requests of candidates who obtained the entry level qualification from Foreign Educational Institutions along with UGC Equivalence Certificate, failing which the request will not be entertained by the University.

Although this office had already issued Notification No. VTU/BGM/SA/Aca-Circulars/2025-26/1271 dated 04-06-2025 (copy enclosed), instructing not to send parents or candidates to the University regarding this matter, it has been observed that many colleges continue to do so. This practice places an unnecessary burden on both the parents and the University, diverting valuable resources to handle such individual visits.

Therefore, as previously informed, Principals/Heads of Institutions are required to verify the academic eligibility of candidates using original documents before granting admission. In case of any ambiguity or doubt, the matter should be referred to the University through an official communication.

Applicants passed from any of the following qualifying examinations are eligible to seek admission to under graduate programmes of this University. However, they have also to satisfy the programme-wise academic eligibility notified as above:

- The 10+2 level examination in the 10+2 pattern of examination of any recognized Central/State Board of Secondary Education.
- Intermediate Science or Two-year Pre-University Examination conducted by a recognized Board/University.
- Final Examination of the two-year course of the Joint Services Wing of the National Defense Academy.
- General Certificate Education (GCE) Examination (London/Cambridge/Sri Lanka) at the Advanced level with minimum passes of 2/3 subjects.
- High School Certificate Examination of Cambridge University
- International Baccalaureate Diploma Program with the minimum passes of 6 subjects (3HL and 3SL) with 24 points.
- Any Public School/Board/University Examination in India or in foreign countries recognized by the Association of Indian Universities as equivalent to 10+2 system.
- Senior Secondary School Examination conducted by the National Open School with minimum five subjects.
- H.S.C. Vocational Examination
