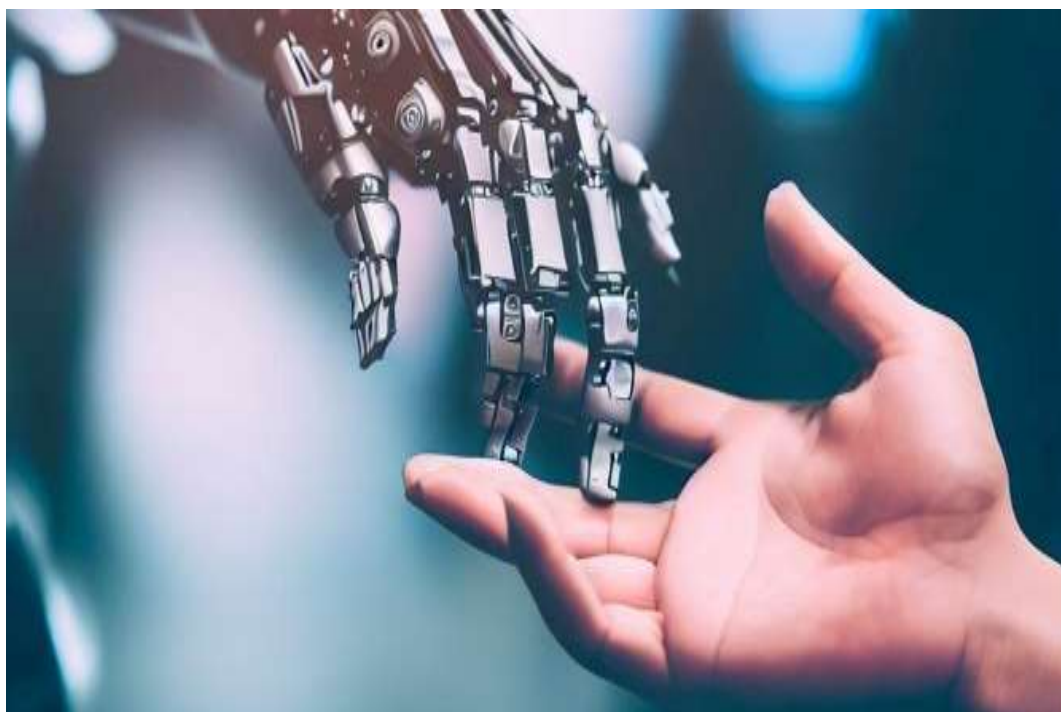

- (ii) Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical Vocational subject or Computer Science or Information Technology or Informatics Practices or Agriculture or Engineering Graphics or Business Studies or Electronics or Entrepreneurship and obtained at least 45% marks (at least 40% marks, in case of Backward class categories, Economically Weaker Section and Persons with Disability candidates belonging to Maharashtra State only) in the above subjects taken together and The Candidate should have appeared in all the subjects in MHT-CET 2024 and should obtain non zero score in MHT-CET 2024. Or Eligibility test conducted by PERA.
Or
- (iii) Passed minimum 3 years Diploma in Engineering and Technology and obtained at least 45% marks (at least 40% marks, in case of Backward class categories, Economically Weaker Section and Persons with Disability candidates belonging to Maharashtra State only);

- Passed HSC or its equivalent examination in any science stream.

- The candidate should be an Indian National;
- Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of Backward class categories, Economically Weaker Section and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together;
- The candidate should have appeared in all the subjects in MHT-CET 2024 and obtain non zero score in MHT-CET or NEET or PERA CET 2024.

(2) All India Candidature Candidates

- The candidate should be an Indian National;
- Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of Backward class categories, Economically Weaker Section and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together;
- Should obtain non zero positive score in NEET or the candidate should have appeared in all the subjects in MHT-CET 2024 and obtain non zero score in MHT-CET 2024. However, preference shall be given to the candidate obtaining on zero positive score in NEET over the candidates who obtained non zero score in MHT-CET 2024.

- For sponsored candidates, minimum of two years of fulltime work experience in a registered firm/ company/industry/ educational and/ or research institute/ any Government Department or Government Autonomous Organization in the relevant field in which admission is being sought.

 - The Candidate should be an Indian National;
 - Passed HSC or its equivalent examination in any science stream.

(a) Candidate should be a Graduate in any Faculty of any University in Maharashtra established by an act of Parliament or by a State Legislature or an equivalent National

Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an Authority competent to declare equivalence, With Minimum of 45% marks in aggregate in qualifying examination in case of candidates belonging to OPEN, EWS & ORPHAN category Candidates (That is 45% marks for all the parts of the Degree Examination taken together). 40% marks in aggregate in qualifying examination (That is 40% marks for all the parts of the Degree Examination taken together) in case of Candidates belonging to SC & ST Categories belonging to Maharashtra State. 42% marks in aggregate in qualifying examination (That is 42% marks for all the parts of the Degree Examination taken together) in case of candidates belonging to VJNT, SBC and OBC Categories belonging to Maharashtra State.

(b) An applicant/s who has passed the U.G. degree and 2/3 years P.G. degree from University in Maharashtra mentioned in (a) after processing the studies in the pattern 12th+3+2/3 with minimum marks as stated in (a): Provided that, the applicants who have obtained +2 Higher Secondary Pass Certificate or First Degree Certificate by Distance or Correspondence method shall also be considered as eligible for Three Year Law Course. Further provided that, no candidate from the open University having a degree contrary of the U.G.C. Act and regulations and contrary to Rules of Legal Education shall be eligible.

(c) The qualifications of 10th (SSC), 12th (HSC) (+2) and Graduation may be obtained through any mode (Distance / Correspondence / Open schooling method). (d) The Applicant/s must obtain basic qualification for admission to Three Year Law course for which the Basic Qualification shall be 12th (HSC) which shall be required to be followed by Three Year Graduation.

(e) Obtained score in CET conducted by the Competent Authority. i.e. Non Zero Score in MAH-LLB-3 CET 2024. Note: The percentage of marks shall not be calculated by rounding off to nearest integer. Or PERA CET 2024.

(2) All India Candidature Candidates, Union Territory of Jammu & Kashmir and Union Territory of Ladakh Migrant Candidature Candidates. –

(a) The candidate should be an Indian National;

(b) Candidate should be a graduate in any Faculty of any University established by an act of Parliament or by a State Legislature or an equivalent National Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, With Minimum 45% marks in aggregate in qualifying examination (That is 45% marks for all the parts of the Degree Examination taken together).

(c) An applicant who has passed the U.G. degree and 2/3 years P.G. Degree from University in Maharashtra/ Outside Maharashtra/ Outside India mentioned in (b) after processing the studies in the pattern 12th+3+2/3 with minimum marks as stated in (b): Provided that, the applicants who have obtained +2 Higher Secondary Pass Certificate or First Degree Certificate by Distance or correspondence method shall also be considered as eligible for Three Year Law Courses. Further provided that, no candidate from the Open University having a Degree contrary of the U.G.C. Act and regulations and contrary to Rules of Legal Education shall be eligible.

(d) The qualifications of 10th (SSC), 12th (HSC) (+2) and Graduation may be obtained through any mode (Distance / Correspondence / Open schooling method). (e) The

Applicant/s must obtain basic qualification for admission to Three Year Law course for which the Basic Qualification shall be 12th (HSC) which shall be required to be followed by Three Year Graduation.

(f) Obtained score in CET conducted by the Competent Authority. i.e. Non Zero Score in MAH-LLB3 CET 2024. Note: The percentage of marks shall not be calculated by rounding off to nearest integer or PERA CET 2024.

Admission Cancellation Rules:

- After receiving duly signed admission cancellation request letter from the Candidate as per schedule published by the Sanjay Ghodawat University, the University shall cancel the admission immediately.
- The refund of fees on or before cut-off date of admission declared by the Sanjay Ghodawat University, shall be made within two days i.e., total fee minus the processing charges of Rs.1,000/-, or refund rule shall be as per the guidelines of the appropriate authorities or the State Government, as the case may be.
- If the admission is cancelled after the cut-off date of the admission declared by the Sanjay Ghodawat University, there shall be no refund except the Security Deposit and Caution Money Deposit.
- No institution, who has in its possession or custody, of any document in the form of certificates of degree, diploma or any other award or other document deposited with it by a person for the purpose of seeking admission in Sanjay Ghodawat University, shall refuse to return such degree, certificate award or other document with a view to induce or compel such person to pay any fee or fees in respect of any course or program of study which such person does not intend to pursue or avail any facility in University.

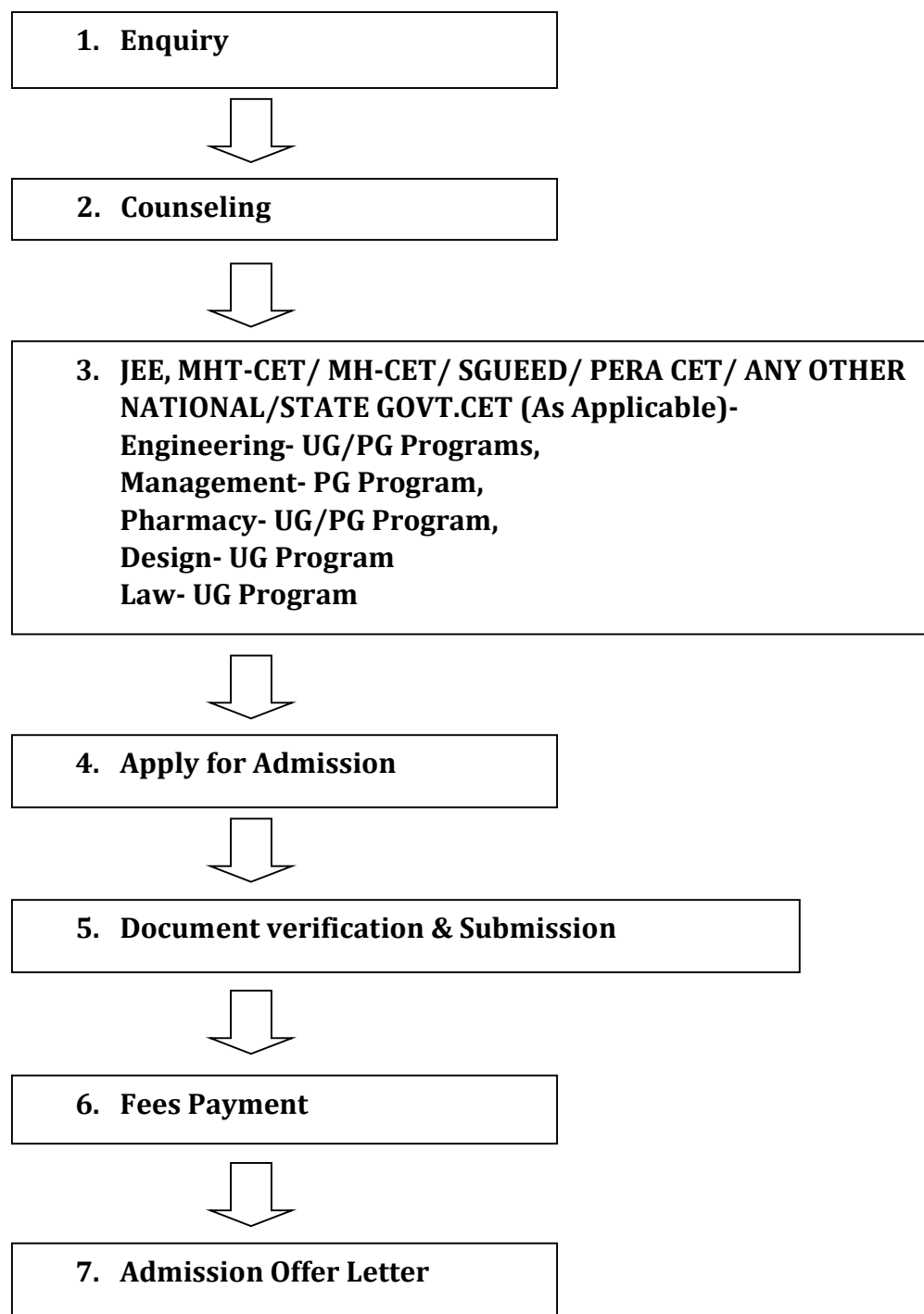
13. Withdrawal or Cancellation Procedure

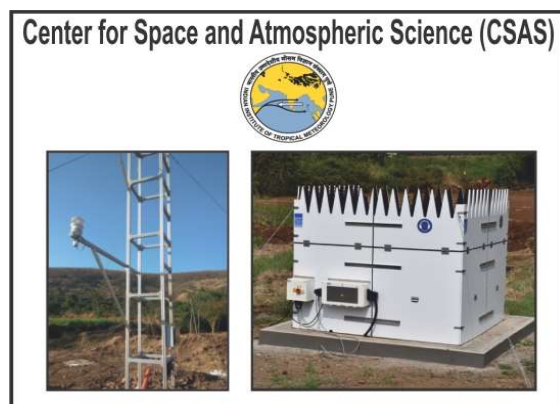
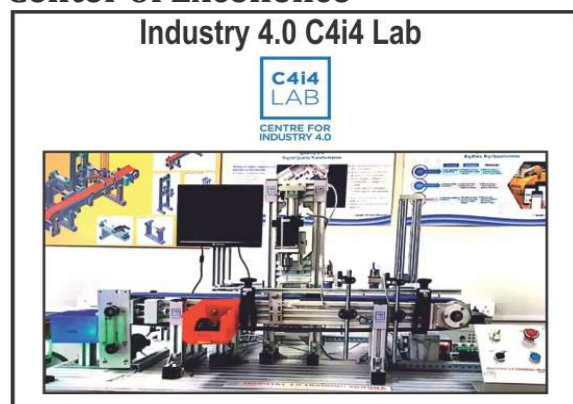

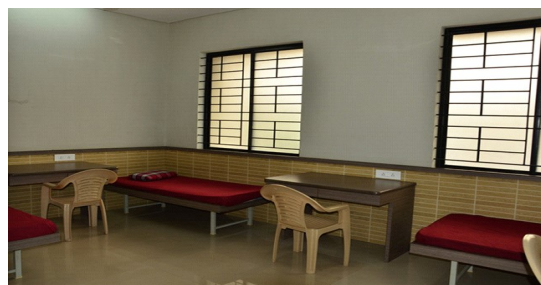

In 2001, he started a Blood Bank by the name 'Acharya Shree Tulsi Blood Bank' at Udgaon (Jaysingpur) equipped with sophisticated laboratory equipment and has been rated as one of the best three blood banks in India.

Mr. Ghodawat also started a Junior Girls College in 2007, educating over 1700 girls and is now planning to start a Dental and Nursing College, Diploma courses and Pharmacy College.

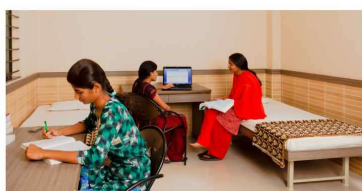
