1. Which of the following is the largest tribal group in India?

- (A) Gonds
- (B) Bhils
- (C) Bodos
- (D) Andamanese Islanders

Correct Answer: (B) Bhils

Solution:

Concept:

India has a very large tribal population distributed across different states and regions. These tribal communities are officially recognized as Scheduled Tribes under the Constitution of India. Some major tribal groups include Bhils, Gonds, Santhals, Bodos, Nagas, and many others. Among these tribes, population size is an important criterion often asked in examinations related to Indian Society, Sociology, Anthropology, and General Knowledge. The Bhils are considered the **largest tribal group in India** in terms of population. They are mainly concentrated in the western and central parts of India, especially in:

- Rajasthan

- Gujarat
- Madhya Pradesh
- Maharashtra

They have a rich cultural heritage, traditional art forms, folk dances, and strong historical significance.

Step 1: Understanding Option (A) — Gonds

The Gonds are one of the oldest and most important tribal communities of central India. They are mainly found in:

- Madhya Pradesh
- Chhattisgarh
- Maharashtra
- Telangana

However, their population is much smaller compared to the Bhils and Gonds.

Therefore, Option (C) is incorrect.

Step 4: Understanding Option (D) — Andamanese Islanders

The Andamanese tribes are indigenous tribal groups living in the Andaman and Nicobar Islands.

These include:

- Jarawas
- Sentinelese
- Onges
- Great Andamanese

These tribes have very small populations and are among the most isolated tribal groups in the world.

Hence, Option (D) is incorrect.

Final Conclusion:

Since the Bhils constitute the largest tribal population in India, the correct answer is:

(B) Bhils

During British colonial rule, tribal societies experienced major economic, social, and administrative transformations. Weekly tribal markets, also called *haats*, became centers through which colonial economic systems penetrated tribal regions.

The British introduced:

- Roads and transport systems
- Commercial trade networks
- Money economy
- Revenue systems

These changes often harmed tribal autonomy and traditional lifestyles.

Step 1: Examining Statement A — Tribals lost control over their land

Under colonial administration:

- Forest laws restricted tribal access to land
- Zamindars and contractors acquired tribal lands
- Revenue policies forced many tribals into debt

As a result, tribal communities gradually lost control over their traditional landholdings. Therefore, Statement A is correct.

- **Green Issue:** Protection of ecology, forests, and environment

The environmental dimension emphasized that forests are valuable not merely for commercial timber but for:

- Soil conservation
- Water preservation
- Ecological balance
- Sustainable living

Step 1: Understanding Option (A)

The movement certainly empowered villagers and gave local communities a voice against exploitation.

However, empowerment relates more to social justice and participation rather than directly explaining why the movement became a *Green* issue.

Therefore, Option (A) is incorrect.

Land tenure systems in India refer to the methods through which land ownership, land revenue collection, and agricultural relations were organized. During British rule and after independence, several land systems and reforms were introduced to improve agricultural productivity and reduce exploitation.

The important systems involved in this question are:

- **Zamindari System** – A system where intermediaries called zamindars collected revenue from peasants.
- **Raiyatwari System** – A direct settlement system between the government and cultivators.
- **Tenancy Abolition and Regulation** – Reforms introduced to protect tenants and provide land rights.
- **Land Ceiling** – Laws imposing maximum limits on land ownership to reduce inequality.

The question requires correctly matching these systems with their outcomes or associated features.

Step 1: Matching Zamindari System with its description

The **Zamindari System** was introduced mainly by Lord Cornwallis under the Permanent Settlement of 1793.

Under this system:

- Zamindars acted as intermediaries between peasants and the British government.

- Peasants were heavily exploited.
