***In case of a tie between candidates, the order of the merit list will be subject to UG percentage.**

Note:

1. The candidates selected against Supernumerary (SN) General shall have to pay 1.5 times the tuition fee for the program, while other components of the fee structure shall remain the same. However, the student shall pay normal fee for the time being.
2. In case, any seat in 'open merit' becomes vacant before the closure of admission, candidates selected in SN-General will be considered for open merit based on their merit in CUET. Such students need not to pay extra fee as mentioned in Note 1 above. Accordingly, the candidate in SN General Waiting List will get promoted to Provisional Selection List in SN General Category.

GENERALINSTRUCTIONS:

1. The above-mentioned candidates falling in the provisional merit list are informed to complete their admission formalities through Samarth portal **by or before 04/09/2025 (Thursday) by 11:59 PM**. However, if any vacancy arises the same will be filled from the waiting list in order of the CUET merit in due course of time.
2. All admissions are provisional, subject to final/physical verification of the documents by the admission committee.
3. The candidate/s whose results are pending/awaited shall have to fulfill their eligibility conditions within a stipulated time/before the commencement of classes. If the candidate/s fails to fulfill the required eligibility condition, his/her admission shall be cancelled.
4. In case of tie (applicants having equal merit in CUET), the order of merit will be decided based on the declaration of UG result of candidate. One who has secured higher marks in qualifying examination will be preferred in order of his/her merit.
5. All the provisionally selected candidates must deposit their admission fees by or before the given time.
6. If a candidate/s fails to deposit the admission fee, they shall forfeit their right to admission, and accordingly, the seat shall be offered to the next candidate in the merit list.
7. Candidates are required to submit the following documents at the Department before the commencement of class work for which shall be notified in due course:
 - i. CUET Application Form
 - ii. Qualifying (graduation) marks certificate in original and a self-attested xerox copy of the same

- iii. Date of Birth certificate
- iv. Domicile Certificate
- v. Provisional & Character certificates in original
- vi. Relevant Category Certificate issued by the competent authority in the prescribed format
- vii. Migration certificate in original.
- viii. Two recent passport size photographs.
- ix. Fee acknowledgement receipt.
- x. CUET score card
