IMPORTANT POINTS

1. Post-Graduate (PG) Programmes are offered by the University of Delhi (UoD) through its Departments/ Centres under different Faculties, namely Arts, Applied Social Sciences & Humanities, Education, Interdisciplinary & Applied Sciences, Music and Fine Arts, Commerce & Business Studies, Law, Medical Science, Mathematical Sciences, Science, and Social Sciences.
2. For the academic session 2026-27, candidates who have completed a Four-Year Undergraduate Programme under UGCF 2022 (Under NEP 2020), from the University of Delhi, will be eligible for admissions (as per eligibility criteria) to the One-year PG Programmes.
3. Admissions to One-year PG Programmes are done based on the eligibility criteria and procedures specified by the University on its admission website and this Bulletin of Information. There are no additional eligibility criteria besides the ones stipulated by the University through its website, Bol(PG-1yr) - 2026.
4. The (pgportal.uod.ac.in) will serve as a single window for admission to all PG one-year Programmes of all Departments/Centres of the UoD, as applicable. All candidates desirous of taking admission to a Programme of UoD should apply only through (pgportal.uod.ac.in). Only admissions taken, granted and through the official online platform of the UoD will be considered valid.
5. Admissions to the One-Year Postgraduate Programmes listed in this BOI will be based on the merit scores obtained after completing four years of Bachelor's Degree Programme of the University of Delhi as per the respective Programme-Specific Eligibility published in this bulletin.
6. Candidates who have graduated with a Four-year Bachelor's Degree from School of Open Learning (SOL)/ Non-Collegiate Women Education Board (NCWEB) will be eligible to apply for One-year PG Programmes.
7. The rules stated in this BOI(PG-1yr) -2026 will be applicable for provisional admission to One-year PG programmes of UoD for the academic session 2026-27.
8. Candidates applying to UoD must refer to the Bol(PG-1yr) - 2026 for minimum eligibility criteria and programme-specific eligibility criteria.
9. It is mandatory for the candidate to apply online through (pgportal.uod.ac.in) portal of UoD. Application submitted through any other mode will not be accepted under any circumstances.
10. Candidates must refer to the list of programmes, programme-specific eligibility criteria, seat matrix, fee structure and other relevant information published on the admission website of UoD/colleges/ departments.
11. There will be a one-time Application fee (non-refundable)

12. The application process for a particular programme will be considered completed only after the realization of the application fee for that programme. Application fee deposited via any other link or mode other than the payment link provided by the portal (pgportal.uod.ac.in) will not be considered under any circumstances. The application fee will not be refunded under any circumstances.
13. If a candidate has applied for a One-Year PG programme but doesn't fulfil the eligibility criteria as per the requirements of the particular programme, his/her candidature will not be considered.
14. As per Ordinance I of the University, there is no minimum age bar for admission to UoD
15. If all the documents are found to be in order and the eligibility criteria are met by the candidate, the allocated seat will be provisionally approved by the Department/Centre. In that case, the candidate will have to pay the admission fee within the stipulated time to secure admission.
16. Fees paid on any other portal of University of Delhi will not be adjusted to the portal meant for admissions to One-year PG Programmes, and vice versa.
17. The candidate must adhere to the stipulated timelines of all allocation and admission rounds.
18. A candidate whose documents are found to be invalid owing to willful forgery/act of cheating will be debarred from admission.
19. Determination of eligibility and verification of documents for admission to UoD will be the sole purview of UoD.
20. In case the seats of Supernumerary Quota/s remain vacant, the same will not be converted to any other category. The UoD is not bound to fill the Supernumerary seats.
21. Candidates are advised to check their dashboard, registered email, and admission website (www.admission.uod.ac.in) regularly for all communications and updates related to admissions.
22. UoD will not be responsible for a candidate's lack of awareness of the admission guidelines, schedule, and eligibility criteria rules. It is the sole responsibility of the candidate to keep checking the dashboard, registered email and admission website of UoD regularly.
23. In case of non-compliance with the requirements for admission, including non-submission of relevant documents and/or non-payment of fee/s within the stipulated date and time, the candidate will lose his/her right to admission.
24. The candidate will be required to appear in person for verification of the original documents as and when notified by the University/Department/Centre.

25. It is the sole responsibility of the candidate to prove his/her eligibility for claiming reservation under any of the reserved categories (including PwBD, Orphan, and SGC). Candidates applying under SC/ST/OBC-NCL/EWS/PwBD/Orphan/SGC categories will be required to upload the certificates/documents of the respective reserved category/sub-category issued by the competent issuing authority. The name of the candidate claiming reservation must match the candidate's name as it appears on his/her corresponding School/Board/qualifying examination certificates. Similarly, the parents' names must also match in all the certificates/documents.
26. If at any stage, documents submitted by the candidate relating to the admission are found to be fake/non-genuine and/or fabricated, or in any other manner defaced, the said candidate will not be given admission, and if already granted, admission will be cancelled without any prior notice in this regard. If the same is found after completing the programme, his/her degree will be revoked, and appropriate legal action will be taken against him/her.
27. A candidate's participation in the admission process will be provisional. If, at any stage, it is found that eligibility requirements are not fulfilled, the admission, if granted, shall be cancelled ipso facto, and appropriate legal action will be taken against such a candidate. The university will not refund the fee in case any candidate is found ineligible at a later stage.
28. Candidates are advised to check that they satisfy all eligibility criteria for the programme(s) for which they are seeking admission. Admission is subject to the candidate's fulfilling the eligibility requirements prescribed for the concerned programme. If at any stage, it is found that the eligibility requirement/s is/are not fulfilled, and/or if the claim/s made by the candidate with respect to his/her category, gender, etc. is/are found to be invalid, the admission, if granted, shall be cancelled ipso facto. Appropriate legal action will be taken against such a candidate.
29. The entire admission process for PG programmes is online, only through the portal (pgportal.uod.ac.in). This includes uploading of documents, payment of fees, withdrawal of admission, etc. University of Delhi will not entertain any request related to admissions/withdrawals/corrections sent by the candidate through post/fax/WhatsApp/e-mail/by hand/phone calls.
30. The University reserves the right to cancel the admission of any candidate who violates the rules and regulations laid down by the UoD.
31. All candidate is advised to read the BoI carefully and consult the University of Delhi Act, 1922 and the Statutes and its amendments from time to time. The Ordinances, Rules, and Regulations of the UoD, available on the University website, would be binding to the candidate.

REGISTRATION, PROGRAMME SELECTION AND ALLOCATION

The admission to the One-Year PG Programme is divided into three phases:

Phase I: Registration for One-Year PG Programme

Phase II: Programme Selection

Phase III: Allocation and Admission

PHASE I: REGISTRATION FOR ONE-YEAR PG PROGRAMME

Before applying, the candidate must scan and keep a copy of all the required documents/certificates on his/her Computer/Laptop. (Refer to Annexure I for the List of Required Documents).

A: NEW REGISTRATION

A new user will have to register to One-Year PG Admission Portal - 2026 (pgportal.uod.ac.in) by clicking on the “**NEW REGISTRATION**” button.

The candidates will have to enter the following details:

- UoD Enrollment Number
- Date of Birth

For successful registration, the candidates will have to enter the OTP received on the email registered at UoD’s SLC portal.

Upon successful registration, the candidate must log in to his/her dashboard to complete the registration.

B: PERSONAL PROFILE SECTION

In this Section, the candidates will have to provide their personal details. The details entered must match the particulars mentioned in the certificates/ documents of the candidate. Kindly note that mismatches/ discrepancies may lead to the rejection of the application form at any stage.

The following fields will be auto-integrated through the SLC portal of UoD:

- **Candidate’s Name**
- **Date of Birth**
- **Email**
- **Mobile No.**
- **Category (as per UoD’s SLC portal)**

ADVICE

Candidate must fill the Application form with utmost care, as editing will not be allowed once the form is successfully submitted.

ADVICE

Candidates must remember their login details, Enrolment Number, email id and password.

C: UPLOADS

The candidate must upload the required relevant documents.

The candidate shall be responsible for the quality and authenticity of the certificate s(he) uploads. S(he) must take utmost care to ensure that uploaded documents/ certificates are authentic and accurate.

ADVICE

Candidates must ensure that the uploaded certificates are visible and readable.

If any false attestation/ falsified records are found, the candidate will be debarred from the University and penal action will be taken against the candidate. Fee submitted will not be refunded in such cases.

D: ACADEMIC SECTION

The following fields will be auto-integrated through the SLC portal:

- Name of the College
- Name of the Programme

In this Section, the candidate has to select the courses that award a major in the relevant discipline on the portal, which determines his/her eligibility for the respective Programme.

E: PREVIEW

The candidate must carefully review their application. S(he) must check all details and, upon satisfaction, s(he) must proceed to make payment. Once the fee is paid, the candidate will not be able to edit/add/delete the information submitted by him/her.

ADVICE

Candidates must pay the application fee well before the deadline in order to avoid any last-minute haste.

A candidate will become eligible to participate in the allocation after the payment has been realised successfully within the stipulated time. The fee must be paid only through the Payment Gateway link provided on the candidate's dashboard. The candidate can only pay the application fee through the designated online link; no other payment method is available. If the application fee is not successfully remitted, the application will not be considered for allocation under any circumstances.

ADVICE

Upon successful payment of the application fee, candidates are advised to keep records of the transaction details as proof for future reference.

No undertaking in lieu of incomplete/ non-availability of certificates/ documents will be accepted.

UoD will not entertain any request for corrections sent by the candidate through post/fax/WhatsApp/e-mail/by hand.

PHASE II: PROGRAMME SELECTION

After the declaration of results of Four-year (8 semesters) Undergraduate Programme, the UoD will open Phase II of Registration.

The candidate must confirm the Programme-Specific Eligibility by selecting the courses that award a major in the relevant discipline on the portal. The merit of the candidate will be determined as per the Programme-Specific Eligibility selected by him/her.

ADVICE

Candidates must upload the latest documents/ certificates. The same will be required during physical verification.

PHASE III: ALLOCATION AND ADMISSION

SECTION – I: ALLOCATION RULES

1. The merit list will be made in the order of Programme-Specific Priorities. The seats will first be filled by the candidates from priority P1 in order of their merit. If seats remain vacant after exhausting all candidates from P1, then candidates from priority P2 will be considered in the respective category, followed by P3 and P4, respectively.
2. In the event of a tie, where two or more candidates applying for the same programme have the same CGPA of 8 Semesters, the following rules will be applied in the stated order to break the tie:
 - (i) The candidate with the higher CGPA of the first seven semesters will be given preference.
 - (ii) If the tie persists, the candidate with the higher CGPA in six semesters will be given preference. Then the higher CGPA of the preceding semesters and so on will be considered for breaking the tie, if required.
3. The merit list for the UR category seats will comprise all candidates in order of merit. No one will be excluded from the same. In other words, the merit list for the unreserved (UR) category will also include SC/ST/OBC-NCL/EWS candidates, irrespective of category, if they meet the criterion of merit for the UR category. No candidate can be excluded from the UR category merit list just because the Candidate belongs to or has applied under SC/ST/OBC-NCL/EWS category. Discrimination based on category/ caste is completely unlawful. The University of Delhi does not tolerate discrimination against any candidate/student on this basis. Strict action will be taken against any violations.
4. If candidates belonging to SC/ST/OBC-NCL/EWS/PwBD/SGC/Orphan category do not have a valid certificate/ document issued by the respective issuing authority at the time of allocation, they will not be considered for admission in the relevant category as claimed. Refer to Annexure-II for details related to category certificate.
5. If the total number of eligible ST category candidates who have applied for a particular Programme exhausts, then the remaining seats under this category for that particular Programme will be allocated to eligible SC category candidates and vice-versa.
6. In case a candidate who was allocated a seat under any reserved category/ sub-category and was rejected on the basis of deficiency/ies in the category/sub-category/ caste documents, s(he) may be considered for seat allocation in subsequent round/s (if any) in UR category as per his/her eligibility, merit, and availability of seats in the UR.

SECTION – II: ALLOCATION, ACCEPTANCE, AND APPROVAL

On declaration of allocations, as per the schedule(as announced on UoD admissions website), the candidate must log on to his/her dashboard to check if a seat has been allocated.

A: ACCEPTANCE OF THE PROVISIONALLY ALLOCATED SEAT

Once a seat has been allocated, the candidate **must 'Accept' the Allocated Seat** before the last date/time specified for the given allocation round. The provision for acceptance of a particular allocated seat will be valid only for the round in which the seat was allocated to the candidate.

Inactivity/no-action will be taken as non-acceptance of the allocated seat. It will be treated as a decline to the provisionally allocated seat, and the candidate will no longer be able to participate in subsequent rounds.

B: ONLINE APPROVAL BY THE DEPARTMENT/ CENTRE

Once the candidate "Accept" the provisionally allocated seat, the concerned Department/ Centre will check the eligibility and documents uploaded by the candidate. The Department/ Centre will verify the following within the stipulated timeline:

1. Minimum Eligibility
2. Programme-Specific Eligibility
3. Validity and authenticity of Documents/Certificates

During the online approval process, if a Department/ Centre seeks more clarity/information from the candidate, it may raise a query to the candidate.

After verification, the Department/ Centre will either 'Approve' or 'Reject' the provisionally Allocated Seat of the candidate. No application will be left unattended by the Department/ Centre.

In case of Approval:

Once the Department/ Centre accords approval, the candidate **will have to pay the 'Admission Fee'**.

In case of Rejection:

At the time of online verification, if an application gets rejected, the Department/ Centre will state the reason for rejection

C: RESPOND TO QUERIES (IF ANY) DURING APPROVALS

During the online approval process, if a Department/ Centre raises query(ies) then the candidate must respond online (through the candidate's dashboard) within the stipulated time. Failure to respond to the query(ies) will lead to rejection of the allocated seat.

ADVICE

Candidates must check the schedule of activities for admission, available on the admission website of UoD (admission.uod.ac.in).

ADVICE

Candidates must regularly check their dashboard and respond to queries (if any) raised by the Department/ Centre within the stipulated time.

D: ADMISSION TO THE PROVISIONALLY ALLOCATED SEAT

After the Department/ Centre approves, the candidate **will have to pay the Admission Fee** for the approved seat within the stipulated time through the link generated on his/her dashboard only. The admission process will be treated as complete only after successful payment of the admission fee.

ADVICE

Candidates must make the payment well in time and not wait for the last date.

If a candidate fails to pay the admission fee within the stipulated time, it will be considered as a cancellation of the provisionally allocated Seat. The allocated seat shall be forfeited, and the candidate will not be considered for any subsequent rounds. The candidate will forfeit all the rights of the allocated seat.

E: IMPORTANT NOTE

Departments/Centres should exercise utmost caution and due diligence while verifying the online documents submitted by candidates during the admission process.

All concerned must:

- thoroughly scrutinize original documents at the time of verification.
- cross-verify marksheets, certificates, and other credentials from the website of issuing authorities or the QR code, as the case may be.
- if the documents are in digital format, the same may be cross-checked by scanning the QR Code embedded in the document, or by checking the same through websites such as DigiLocker, eMitra, NCBC, Department of Empowerment of Persons with Disabilities, etc. The Issuing authorities may also be contacted for the purpose of verification.
- report any suspicious or doubtful documents immediately to the competent authority for further investigation.
- keep a record of the verification process for audit and accountability.

This precautionary measure is essential to maintain the integrity and fairness of the admission process. Non-compliance or negligence in this regard will be taken seriously.

SECTION – III: CANCELLATION OF PROVISIONALLY ALLOCATED SEAT/ ADMISSION

1. The provisionally Allocated Seat/Admission will be cancelled at any time if it is found that a candidate does not meet the Minimum Eligibility Criteria / Programme-Specific Eligibility as declared by UoD.
2. Failure to 'Accept' the provisionally Allocated Seat within the stipulated timeline will lead to the cancellation of the Allocated Seat.
3. The provisionally Allocated Seat will be cancelled if a candidate fails to pay the admission fees within the stipulated time.
4. Failure to respond to the query(ies) may lead to the cancellation of the allocated seat.
5. The provisionally Allocated Seat/Admission will be cancelled if, at any time, any of the document(s)/certificate(s) is/are found to be invalid/fraudulent.

A candidate whose provisionally allocated seat/admission is cancelled due to the above-mentioned reasons will forfeit the right to seek admission to UoD.

SECTION – IV: REMITTANCE OF FEE

Admission of a candidate will be deemed confirmed only after the successful realisation of the Admission Fee. The admission fee must be paid only through the candidate's dashboard. If the admission fee is not

successfully remitted within the stipulated time, the admission will not be considered complete under any circumstances.

For all payments, candidates should use any of these payment modes: Net Banking / Debit Card / Credit Card / UPI.

ADVICE

Candidates are encouraged to make payments through their own/parent's account/UPI/Card.

A: PAYMENT FAILURES

1. If the amount is not deducted from the account, the candidate must try paying again before the payment deadline.

2. Candidate must ensure a stable internet connection is used for making the online payment.

3. Candidate must use the correct credentials to make a successful payment.

4. If the amount is deducted, but a notification is not received, the candidate may seek confirmation from his/her source bank.

SECTION – V: REFUND POLICY

Admission Fee on account of withdrawal of the admission by the admitted candidate will be refunded as per the UoD notification dated 01.06.2026 (<https://www.du.ac.in/uploads/2026/01062026-notice-fee-refund.pdf>). **Application Fee will not be refunded under any circumstances**

SECTION – VI: MANDATORY REQUIREMENT FOR PHYSICAL VERIFICATION OF ORIGINAL DOCUMENTS

All admitted candidates will have to report to the admitted Department/ Centre and complete all the admission formalities of the concerned Department/ Centre, including physical verification of the documents/ certificates as per the notification issued by the concerned Department/Centre.

Admission of a candidate is purely provisional and is subject to verification of original documents by the respective Department/ Centre. The Department/ Centre will recheck all the documents/certificates. During physical verification, if any document/certificate is found inadequate/insufficient/ inappropriate, it will lead to cancellation of the admission, *ipso facto*. Further, such a candidate will forfeit the opportunity for admission to any PG Programme of UoD for the Academic Session 2026-27.

SECTION – VII: GRIEVANCE REDRESSAL

A: DEPARTMENT/ CENTRE GRIEVANCE REDRESSAL COMMITTEE

Every Department/ Centre will establish a Grievance Redressal Committee to redress grievances that may arise during admission. In addition, a Sub-Committee of Grievance Redressal for redressing the grievances of candidates belonging to SC/ST/OBC/EWS/PwBD categories will also be established. The details of the Department/ Centre Grievance Redressal Committee and the Sub-Committee will be displayed on the website of the Department/ Centre and on the admission website of UoD to facilitate and address the needs/queries of candidates within the stipulated time. Candidates having grievances about admission should first approach the Grievance Redressal Committee of the concerned Department/ Centre.

B: CENTRAL GRIEVANCE REDRESSAL COMMITTEE

If grievance/s is/are not resolved within a reasonable time by the Department, then candidates may approach the Central Grievance Redressal Committee of UoD. The Central Grievance Committee will consider only those grievances that will be received from the Head of the Department, along with the recommendations/remarks

ADVICE

Candidates must first use online facility to approach the Admission Grievance Redressal Committees.

This Committee will resolve allocation and admission-related issues of candidates. The details of the Central Grievance Redressal Committee will be displayed on the admission website of UoD.

If a grievance is found relevant and genuine, and if seats in a specific Programme have been filled, then such a candidate will be offered a supernumerary seat. The decision(s) by the concerned authorities with regard to grievances shall be final and binding.

RESERVATION POLICIES

Reservation of Seats for Scheduled Caste (SC) and Scheduled Tribe (ST)

22.5% of the total numbers of seats is reserved for candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary).

The candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission. The Caste certificate should clearly state:

- (a) Name of his/her caste/tribe
- (b) Whether candidate belongs to SC or ST
- (c) District and the State or Union Territory of candidate's usual place of residence, and
- (d) The appropriate Govt. of India Schedule under which his/her caste/ tribe is approved as SC or ST.

Candidate will have to produce the valid original SC or ST certificate at the time of admission.

The following are empowered to issue the requisite SC/ ST certificate:

- a. District Magistrate / Additional District Magistrate / Collector / Deputy Commissioner / Addl. Deputy Commissioner / Deputy Collector / 1st class Stipendiary Magistrate / City Magistrate / Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner
- b. Chief Presidency Magistrate /Addl. Chief Presidency Magistrate/ Presidency Magistrate
- c. Revenue Officer not below the rank of Tehsildar
- d. Sub-Divisional Officer of the area where the Candidate and/ or his family normally resides
- e. Administrator/ Secretary to the Administrator/ Development Officer (Lakshadweep Islands)

Candidates must note that the SC / ST Certificate **from any other person/authority, other than those mentioned above, shall not be accepted in any case. If the Candidate happens to belong to SC or ST, candidate's caste / tribe must be listed in the appropriate Govt. of India Schedule.**

Reservation of Seats for Other Backward Classes (OBC-NCL, Central List)

27% seats are reserved for the candidates belonging to Other Backward Classes (OBC-Non-Creamy Layer, Central List).

At the time of admission for the candidate belonging to OBC-NCL, the College will ensure that the caste is included in the Central List of OBC (as notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes at its website- ncbc.nic.in)

The certificate must mention non-creamy layer status of the candidate (Non-creamy layer status issued by an authority mentioned in DoPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).

The OBC candidates who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (validity period of OBC certificate in respect of 'non-creamy layer' status of the candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31 March 2016). The certificate should be issued after 31st March, 2026.

Reservation of Seats for Economically Weaker Sections (EWS)

As per the University of Delhi notifications (Reference No. Aca. I / Reservation of EWSs / 2019/ 63 Dated 28th March 2019 and Reference No. Aca. I / Reservation of EWSs / 2019 / 101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments / Centres / Colleges have reserved 10% seats for admission of candidates belonging to EWS category. The EWS certificate should be issued after 31st March, 2026.

ADMISSION UNDER SUPERNUMERARY QUOTAS

Separate allocations will be done for Supernumerary Quotas. Candidates must keep visiting the admission website for guidelines and schedules related to admissions under Supernumerary quotas. They must also regularly check their dashboard.

A: PERSONS WITH BENCHMARK DISABILITY (PwBD)

Five percent (5%) of the total sanctioned strength in each Programme is reserved for PwBD candidates. Separate Allocation will be declared for the candidates seeking admission under PwBD quota on the dashboard of the candidate.

For the prescribed format of the PwBD certificate, refer to Annexure II. Disability Certificates issued after 01.06.2021 must be as per the Gazette Notification no. 1736 (E) dated 05.05.2021 issued by the Department of Empowerment of Persons with Disabilities and applied through the UDID portal. However, Disability Certificates issued before 01.06.2021 will be considered as per other existing applicable rules and notifications of the Department of Empowerment of Persons with Disabilities and the University of Delhi.

As per the Rights of Persons with Disabilities Act, 2016, a 'person with benchmark disability means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority.' It may be noted that the erstwhile Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (No. 1 of 1996), under which reservation for Persons with Disabilities in admissions was provided earlier, has now been repealed.

A person with benchmark disabilities falling within any of the following specified categories of disabilities as mentioned in the Schedule to the Rights of Persons with Disabilities Act, 2016 [See Clause (zc) of Section 2 of the said Act] is eligible to get the benefit of the said reservation.

1. Physical disability

A. Locomotor Disability

Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including-

(a) **"leprosy cured persons"** means a person who has been cured of leprosy but is suffering from-

- (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye lid but with no manifestation of deformity;
- (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
- (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;

(b) **"cerebral palsy"** means a Group of non-progressive neurological condition affecting body movements before, during or shortly after birth;

(c) **"dwarfism"** means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less; 76

(d) **“muscular dystrophy”** means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;

(e) **“acid attack victims”** means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

B. Visual impairment

(a) **“blindness”** means a condition where a person has any of the following conditions, after best correction

(i) total absence of sight;

(ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or

(iii) limitation of the field of vision subtending an angle of less than 10 degree.

(b) **“low-vision”** means a condition where a person has any of the following conditions, namely:

(i) visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or

(ii) limitation of the field of vision subtending an angle of less than 40 degree upto 10 degree.

C. Hearing impairment

(a) **“deaf”** means persons having 70 DB hearing loss in speech frequencies in both ears;

(b) **“hard of hearing”** means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;

D. **“speech and language disability”** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.

2. Intellectual disability

A condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behavior which covers arrange of everyday, social and practical skills, including-

(a) **“specific learning disabilities”** means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;

(b) **“autism spectrum disorder”** means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person’s ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

3. **Mental behavior** “mental illness means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviours, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a persons, specially characterized by subnormality of intelligence.

4. Disability caused due to

(a) chronic neurological conditions, such as-

(i) “**multiple sclerosis**” means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other.

(ii) “**parkinson’s disease**” means a progressive disease of the nervous system marked by tremor, muscular rigidity and slow, imprecise movement, chiefly affecting middle-aged and elderly 77 people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.

(b) Blood disorder

(i) “**haemophilla**” means an inheritable disease, usually affecting only male but transmitted by women to their malechildren, characterized by loss or impairment of the normal clotting ability of blood so that a minor wound may result in fatal bleeding.

(ii) “**thalassemia**” means a group of inherited disorders characterised by reduced or absent amounts of haemoglobin.

(iii) “**sickle cell disease**” means a haemolytic disorder characterised by chronic anaemia, painful events, and the cell membrane of red blood cells resulting in the release of haemoglobin.

5. Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.

6. Any other category as may be notified by the Central Government.

Concessional/waiver of fees in respect of PwBD

a. Candidates with physical disabilities pursuing various programmes of study in the Faculties, Departments, Centres, and Institutions/Colleges of the University shall be exempted from payment of fees, including examination fee and other University fees, except admission fee, subscription towards Delhi University Students’ Union (DUSU) and Identity Card fee (As per amendment to Ordinance X (4) of the University).

b. As per University Notification vide no. Acad.I/PG Fee/PwBD/2022-23 dt.30.11.2022 the candidates belonging to PwBD category for PG Programmes shall be given a fee concession of 75% of the total fees as compared to the other students taking admission in a particular programme of the University.

c. PwBD Candidates who meet the merit for the unreserved category and will take admission in the Unreserved/ OBC-NCL/SC/ST/EWS category will pay the fee relevant for PwBD candidate.

d. As per the Executive Council Resolution No. 50 dated 03.11.2012, students with physical disabilities residing in different Hostels / Halls of the University are exempted from payment of all hostel fees and charges except refundable caution fee and the mess fees. Persons with Physical Disabilities who are students shall pay 50% of the Mess fee and the remaining 50% of their Mess Fee will be met by the University of Delhi. Similar norms are to be adopted by the Colleges in respect of PwBD Students residing in various hostels of the Colleges.

e. Candidates must ensure that the PwBD certificate is in the name of the candidate and issued by a recognized Government Hospital, bearing duly attested photograph of the candidate.

f. PwBD students who are getting fellowships / financial assistance shall be exempted from payment of fees / charges / mess fees subject to the following conditions.

Value of Fellowship	Exemption of Fees waiver etc
Upto ₹ 3000/- per month	Fees waiver +50% Mess Subsidy
₹ 3001/- to ₹ 8000/- per month	Fees waiver but no Mess Subsidy

B: UoD WARD QUOTA

Admission to the wards of the University and its College employees, both teaching and non-teaching, will be done as per Academic Council resolution 9(b) dated 27.11.2020 and subsequent Notification dated 21.12.2020.

Candidate must upload a valid Employment Certificate issued by the due officials. The certificate must clearly mention the status of employment of the parent/s. Only the certificate uploaded on the portal will be considered. I-Card, Aadhar Card, or any other document will not be accepted.

C: ORPHAN QUOTA

The University of Delhi will be admitting two candidates (one male and one female) in each programme of study, both at the undergraduate and postgraduate levels. These two seats will be supernumerary.

The Council of the University further resolved that the expenditure incurred for admission and continuance of study of such students in the University or its Colleges shall be met from the University Welfare Fund or College Students' Welfare Fund, as the case may be, for admissions in the University or in the College.

A candidate who wishes to seek admission under the Orphans Quota will have to upload a certificate from a Govt. recognized Orphanage/Charitable Home or the death certificate of both parents.

As per University Notification No. Acad.I/Orphan Quota/2024-25/10 dated 16th January, 2024 – 1, candidates seeking admission with effect from the Academic Session 2024-25 onwards under the Orphan Quota shall pay the following fees:-

- Admission Fee - ₹ 10.00
- Examination Fee - ₹ 10.00

- Hostel Fee - ₹ 10.00
- Students availing hostel accommodation shall pay Mess Fees as per actuals.

D: SINGLE GIRL CHILD (SGC)

01 (One) seat in each Programme is reserved under the Supernumerary Quota for a single girl child. The Parent/Guardian (in case parents are deceased) will have to declare that the girl child is the only Child of the parents have no other Male/Female child other than the girl child for which the application is being submitted for admissions in the academic session 2026-27. For claiming admission in this category, the Father / Mother / Guardian (in case parents are deceased) shall have to upload copy of an affidavit to this effect, duly attested by the area District Magistrate / Additional Magistrate / Deputy Commissioner / Collector / Additional Deputy Commissioner / Deputy Collector / 1st Class Stipendiary Magistrate / City Magistrate (not below the rank of 1st Class Stipendiary Magistrate), Sub- Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner, at the time of online registration and should produce original affidavit at the time of physical verification of documents (refer to Annexure II for format of affidavit).

8. A candidate who wishes to seek admission under the Orphan quota will have to upload a certificate from a Govt. recognized Orphanage/ Charitable Home or the death certificate of both parents.
9. Candidate claiming admission under Single Girl Child Quota, the Father/ Mother / Guardian (in case parents are deceased) of the candidate shall have to upload a copy of an affidavit to this effect (refer to Annexure II for format of affidavit).
