ADMISSION NOTICE

MBA (Full Time) Programme for the Academic Session 2026-2027

Online Applications are invited from eligible intending candidates for admission to the following Programme for the academic session 2026-2027 offered by the Centre for Management Studies (CMS), Dibrugarh University:

MBA (Full Time) Two Years (Four Semester) Programme (AICTE Approved)

Eligibility :

A Bachelor Degree in any discipline (except Music and Fine Arts) from a recognized Indian University with at least 50% aggregate marks (45% for SC/ST candidates) with any valid MAT/CAT/CMAT Score. Those who are waiting for their final semester examinations / results can also apply.

Admission Procedure:

➤ **MBA (Full Time):** The admission procedure consists of:

1. **Written Test (45% weightage):** Candidates have to take the MAT (Management Aptitude Test) examination conducted by All India Management Association / CAT (Common Admission Test) conducted by IIMs or CMAT (Common Management Admission Test) conducted by AICTE. Sponsored and / or foreign candidates are exempted from appearing in the Written Test.
2. **Group Discussion (30% weightage) and Personal Interview (25% weightage):** Candidates who have a valid MAT / CAT / CMAT Score (as fixed by the Centre after the application process) or otherwise qualified as mentioned above will be called for a Group Discussion and Personal Interview.

The final selection will be based on the candidate's overall performance.

Application Procedure:

1. Application for **MBA (FT) Programme** shall be through online mode only. No other means of application shall be accepted.
2. Online Registration for submission of Application Form will begin from **02.03.2026**. The last date for submission of application is **20.04.2026 (till 11.55 p.m.)**
3. For submission of the **Online Application Form**, intending candidates are advised to follow the following instructions:
 - a) For Online Application, please login to Admission Portal on <https://dibru.ac.in> or <https://erp.dibru.work>
 - b) The Candidate needs to register on the portal by clicking the "Register" button and providing his/her name, mobile number and a password. The mobile number will be verified through an OTP. Please remember the password for login.
 - c) After successful registration, the candidate needs to login using his/her mobile number and the password.

- d) After login, the candidate needs to click on the “Apply” button corresponding to the link of “**MBA Programme**” which will lead to an application form. *The candidate needs to fill up the application form step by step.*
- e) After completion of the filling-up of the form, candidate needs to click the button “Submit and Review”. A preview of the filled-up form will be displayed. Candidates are advised to carefully cross-check the information and if anything needs to be corrected at this stage, they can go back and edit
- f) After ensuring that all the information displayed on the Preview is correct, the candidate needs to click ‘**Pay now & Submit the application**’ and then pay the application fee of Rs 950/- only through online mode (Debit Card/Credit Card/Internet Banking).
- g) The application form will be considered finally submitted only when the application fee is successfully paid by the candidate and an online receipt is generated confirming the payment.
- h) There will be a button to download your Application Form for future reference. Keep a copy of the downloaded form without fail.
- i) The Submission of Online Application Forms shall be automatically closed after the last date.
- j) Candidates seeking admission under the Non-Statutory Reservation Quota in the category of **Sons and Daughters of the DU Employees/Retired Employees** shall have to submit a print out of the Submitted Online Application Form of the MBA (FT) Programme 2026 along with the self-attested copies of all relevant testimonials and a Filled in Prescribed Form at the Centre for Management Studies, Dibrugarh University [*Please refer Clause No. 2 (IV) (b) of ‘Reservation and Relaxation Policy for admission into Post Graduate, Under Graduate, Advanced Post Graduate Diploma, Post Graduate Diploma, Diploma and Certificate Programmes (Revised upto February 2022)* available in the Dibrugarh University Website].

Note : Certificate from competent authority must be submitted. Attach additional sheet(s) if necessary

4. There shall be no alternative procedure for Application for applying to the **MBA (FT) Programme** and the University shall not receive the Application except the procedure mentioned at (2) above.
