Sub: Guidelines & timeline for Phase-II admission into P.G. Courses under SAMS for the Academic Session 2025-26- Regarding

Madam/ Sir,

In inviting a reference to the subject cited above, I am directed to inform you that the P.G. Phase-II admission under SAMS for the remaining seats will be held as per the guidelines mentioned below.

1. The following categories of applicants are eligible to apply:

- a) Applicants, who have appeared in the Common PG Entrance Test (CPET) -2025, but not selected in the Phase-I admission process.
- b) Applicants, who have appeared in the CPET-2025 and selected in the Phase-I admission process but were not admitted due to various reasons.
- c) Applicants, who have appeared in the CPET-2025, but not exercised the choice of preferences within the stipulated timeline in the Phase-I admission process.

2. Applicants who have already been admitted in Phase-I admission process are also eligible to apply in the Phase-II admission process. If an applicant has taken admission in any of the HEIs in Phase-I and got selected in Phase-II, then s/he has to obtain the CLC physically from the last admitted HEIs.

3. Applicants who have already paid the CAF fees during the Phase-I admission process are not required to pay the CAF Fees again while submitting their fresh choices for the Phase-II admission. Such applicants must log in to the SAMS Portal using the same registered username and password created during Phase-I and provide their new preferences of HEIs freshly.


4. All the applicants participating in the Phase-II admission process have to pay the admission fees freshly. If s/he had paid the admission fees earlier in Phase-I admission process but did not take admission for any reason, the amount will be refunded to the account number they have provided in the CAF within due course.

5. The selection of the applicants will be done purely on the merit basis. There will be no reservation and weightage for this Phase-II admission process.
6. There will be no Freeze/ Slide/ Float option available for this Phase-II admission process. After publication of 1st round selection, the selected applicants can download the Intimation Letter from their login and have to pay the total admission fees directly at their selected Institutions in online mode preferably (Net Banking/ Bank Challan/ NEFT/ UPI etc.).
7. In addition to the 1st round selection list, a waiting list shall be provided in the HEI's e-Space as well as the waiting rank in the student's login. In case the applicants (selected in 1st round selection) do not turn up for admission within the stipulated timeline and if vacancy exists after the completion of 1st round admission process, the HEIs can publish the selection list out of the reported waitlisted candidates on merit basis and complete the admission process as per the scheduled timeline.
8. After the publication of the 1st round selection, the upper choice Institutions of an applicant along with not selected applicants will be considered for the waiting list/Spot round admission process.
9. The waitlisted applicants are required to report physically at the respected HEIs for verification of documents as per the approved timeline. The interested applicants must appear in person; however, a representative with valid id proof may also be permitted to report on their behalf. Applicants who fail to report within the stipulated timeframe will not be considered for admission during the waiting List/ Spot Round.
10. Further, HEIs will verify the details of the reported applicants and prepare the merit list as per the vacancy. The HEIs are requested to publish the merit list in their notice board/website and complete the admission process within the stipulated timeline. The selected applicant's higher preference Subject options will be taken in account while preparation of waiting list applicants.
11. The HEIs are hereby instructed to inform the selected applicants via phone call/ SMS/ Whats-app/e-mail (Maintain proper register as a proof of communication) to the selected/waitlisted applicants in order to avoid any future legal complications.
12. The HEIs will prepare and publish two merit lists on their notice board or website: one for selected applicants and another for waitlisted applicants. For example, if an HEI has five vacancies in a subject, they will keep five (5) applicants in the selection list and place twenty Five (25) applicants on the waiting list. The ratio of waitlisted applicants can be decided at the level of HEIs.
13. The "Error Correction" button shall be provided against each selected applicants in the HEI's e-space. The error correction must be authenticated by the Admission-in-Charge during admission process. If any discrepancy found in the CAF, the HEIs can do the necessary error correction by choosing the "Not Allowed" option and can allow him/her to take admission, if his/her marks are coming above the cut-off marks.

14. If an applicant has already been admitted in any of the HEIs during the 1st Round of the Phase-II admission process and gets selected in waiting list/SPOT round of admission, they must obtain the CLC physically from their last admitted HEIs. They need to submit the CLC and other relevant documents at the selected institutions for verification and admission.
15. If an applicant has paid the admission fees during the 1st Round of the Phase-II admission process at a particular HEI and is subsequently selected in the Waiting List/Spot Round at another HEI, the previously admitted HEI must refund the full admission fees (with a deduction of Rs.1000/- as the processing fees) to the applicant at the time of issuing the College Leaving Certificate (CLC). This ensures that the applicant does not face any issues with payment during the waiting list/Spot round admission process.
16. The HEIs are hereby informed not to collect any type of other fees from the applicants (except the processing fees) during issuance of CLC, handing over the Cancelled CLC of +3/equivalent and other required documents. Moreover, HEIs are also informed to accept the Migration certificate of the last attended institution (not the institution where the applicant was admitted in Phase-I) for taking admission in Phase-II admission process.
17. During the Waiting List/SPOT round admission process, if an applicant is selected and admitted to a different Major subject within the same institution and the fee structure remains the same, the HEI shall not collect the fees again. The amount already paid during the 1st round of the Phase-II admission process should be duly adjusted.
18. The HEIs will be held responsible for any kind of mistakes, if found in violation of admission process will be viewed seriously. Show cause notice will be issued for any deviation in the admission process and proper action will be taken as deemed fit.

Therefore, you are requested to follow the above-mentioned guidelines during Phase-II admission process. The timeline for Phase-II admission process is attached at Annexure-I for your reference.

The timeline for Phase-II admission into P.G. Courses for the session 2025-26 in the State Public Universities and Colleges participating in project 'Student Academic Management System (SAMS)' is given below. Any changes in the dateline will be published in the newspapers as well as in the website www.samsodisha.gov.in. Kindly refer the Common Prospectus (CP)/ Guidelines available in the SAMS portal to know about the activities.
