NOTIFICATION No. 059-BOPEE of 2026 Dated 07-05-2026

Online Applications are invited from eligible/desirous candidates who intend to appear in the Common Entrance Test for admission to **M.Sc. Nursing** Courses for the Academic Session-2026 in the Government/Private Colleges/Institutions of the UT of J&K. The selection of the candidates to such courses shall be regulated by the J&K Board of Professional Entrance Examinations Act 2002 and the Rules and Regulations made thereunder; Jammu & Kashmir Reservation Act, 2004 as amended vide J&K Reorganization Act, 2019, J&K Reservation Rules, 2005 and S.O. 176 dated 15-03-2024 read with S.O. 305 dated 21-05-2024 and subject to further amendments, if any, made by the Competent Authority, from time to time.

Important Information:

1. Receipt of Online Application Forms **w.e.f. 08-05-2026 (11:00 A.M. onwards)**.
2. Last date for filling the Online Application Forms **21-05-2026 (Midnight)**.
3. **Fee of Rs. 1500/- (Rupees One Thousand & five hundred only)** to be paid online through National Credit Card/Debit Card/Net Banking.
4. The syllabus for the Common Entrance Test is available in the E-Information Brochure.
5. Date of Common Entrance Test: **To be notified separately**.
6. The Common Entrance Test shall be conducted by the Board through offline mode.

Online Application forms:

The procedure for filling out the online Application Form and eligibility, etc. of the candidates has been given in detail in the e- Information Brochure.

Submission of Online Application Forms:

The interested candidates are required to upload the following scanned Original / Certificates in the PDF format with a size of **100-200 KB along** with the Application Form: -

- (i) Domicile Certificate of UT of J&K/UT of Ladakh, as the case may be (For Candidates of UT of Ladakh, ST certificate issued by the Competent Authority of Ladakh shall be treated as Domicile Certificate),
- (ii) Qualifying marks card of B.Sc. Nursing/ B.Sc. Hons. Nursing /Post Basic B.Sc. Nursing,
- (iii) Registration Certificate issued by the Nursing Registration Council of any State/ UT
- (iv) One year of work experience after B.Sc. Nursing
- (v) One year of work experience before or after Post Basic B.Sc. Nursing
- (vi) Valid Reserved Category Certificate, if any.

However, it is for the information of all the concerned that the afore-titled documents as required for submission of the online application form shall be considered provisional and subject to change(s), if any, as may be notified by the Competent Authority.

ELIGIBILITY FOR ADMISSION:

A candidate must:

- (i) be a domicile of UT of J&K/UT of Ladakh as the case may be (For Candidates belonging to UT of Ladakh, ST certificate issued by Competent authority of Ladakh shall be treated as Domicile certificate);
- (ii) have passed B.Sc. Nursing/ B.Sc. (Hons.) Nursing /Post Basic B.Sc. Nursing with minimum of 55% aggregate marks,
- (iii) should have undergone B.Sc. Nursing/ B.Sc. (Hons.) Nursing /Post Basic B.Sc. Nursing in an institution which is recognized by the Indian Nursing Council.
- (iv) should be a registered Nurse and Registered Midwifery or equivalent with any State/UT Nursing Registration Council.
- (v) have a minimum of one year work experience after B.Sc. Nursing
- (vi) have a minimum of One year work experience prior to or after Post Basic B.Sc. Nursing
- (vii) Valid Reserved Category Certificate, if any.
- (viii) Candidates shall be medically fit.

Syllabus etc.:

The syllabus for the Common Entrance Test is available on the e-information Brochure. The examination shall be conducted in one sitting of **two hours duration**, and the paper shall contain **120 Multiple Choice Questions** comprising different sections.

Note-I

The eligibility is bare minimum/provisional and shall be subject to such changes/benchmarks as may be fixed by the Indian Nursing Council. The Board shall, on receipt of any such communication from the Authority concerned, notify the same, which shall govern the eligibility criteria.

Original Documents required to be submitted to the Institution at the time of Admission: -

- a) Mark's card for B.Sc. Nursing/B.Sc. (Hons.) Nursing/Post Basic B.Sc. Nursing
- b) Domicile Certificate for candidates belonging to the UT of J&K and ST certificate as a Domicile for candidates belonging to the UT of Ladakh;
- c) Registration Certificate issued by any State/UT Nursing Registration Council
- d) Minimum of one year of work experience after B.Sc. Nursing
- e) Minimum of one year of work experience before or after Post Basic B.Sc. Nursing
- f) Category Certificate, if any;
- g) Any other document, which may be required by the Institution.

Venue for Conduct of Examination:

The Common Entrance Examination shall be conducted by the Board through offline mode at Jammu / Srinagar Centres simultaneously as may be decided by the Board.

Issuance of Admit Cards:

Information with regard to the availability of Online Admit Cards and Venue of the Common Entrance Test will be issued separately in due course of time.

NOTE-II:

1. The sports category candidates must indicate their sports category on the Application Form. They are also required to submit their Sports Certificate(s) in the office of the Secretary, J&K Sports Council (as notified by the Council in due course of time) to determine their sports points, which shall later be officially forwarded by the Council to the BOPEE. The J&K BOPEE, however, shall not

be responsible for the non-inclusion of any candidate in the list forwarded by the Sports Council or the delay on their part for submission of sports points to the BOPEE.

2. The candidates having more than one reserved category certificate can get the benefit of only one category indicated and uploaded along with the Application Form, which in no case shall be changed afterwards.
3. The CDP category candidates are advised to write their priority (01-08) in the online Application form issued by the competent authority.

Note-III

1. The submission of the online Application Form is purely provisional and is liable to be cancelled at any stage, subject to the final verification of the documents, and even at any stage, where such a document is proved to be fake/false
2. The candidature of those candidates who may have submitted an incorrect/wrong application form during the online process shall be liable to be rejected without any further notice to such candidates. However, they can rectify their errors, if any, by submitting a physical representation at the J&K BOPEE office, Jammu/Srinagar, on or before the last date fixed by the Board for filling up online application forms.
3. Mere submission of the Application Form and appearance of the aspiring candidate in the Common Entrance Test shall not confer any preferential right/claim for admission upon the intending applicants, but shall be subject to the fulfilment of the eligibility criteria and the qualification prescribed for the said course.
4. The seats shall be provisionally allotted to the candidates purely based on the online information filled by the candidates (including category) during the online application form. In case the candidates have filled /uploaded the wrong category during the online application form, the seat shall be allotted accordingly & the Board shall not be responsible for the same.
