1. Programmes offered:

- (a) B.Sc. Nursing - 4 years programme (semester system)
- (b) Post Basic B.Sc. Nursing – 2 years programme (annual system)

B.Sc. Nursing and Post Basic B.Sc. Nursing Programmes:

The Aims of the B.Sc. Nursing and Post Basic B.Sc. Nursing Programmes are to:

1. Produce knowledgeable competent graduate nurses and midwives with clear thinking skills who are caring, motivated, assertive and well-disciplined responding to the changing needs of profession, healthcare delivery system and society at National Level as well as global.
2. Prepare them to assume responsibilities as professional, competent nurses and midwives in providing promotive, preventive, curative, spiritual and rehabilitative healthcare services in any healthcare setting.
3. Prepare nurses and midwives who can make independent decisions in nursing situations within the scope of practice, protect the rights of individuals and groups and conduct research in the areas of nursing practice and apply evidence-based practice.
4. Prepare them to assume role of practitioner, good researcher, teacher, supervisor and manager in all healthcare settings.

Objectives:

On completion of the B.Sc. Nursing program, the B.Sc. Nursing graduates will be able to:

- Utilize critical thinking to synthesize knowledge derived from physical, biological, behavioral sciences, and humanities, in the practice of professional nursing and midwifery.
- Practice professional nursing and midwifery competently and safely in diverse settings, utilizing learning, critical thinking and therapeutic nursing interventions with individuals, families, populations and communities at any developmental stage and with varied lived health experiences.
- Provide promotive, preventive and restorative health services in line with national health policies and programs.
- Integrate professional caring practice decisions that encompass values, ethical, and moral and legal aspects of nursing.
- Respect the dignity, worth, and uniqueness of self and others.
- Apply concepts of leadership, autonomy and management to the practice of nursing and midwifery to enhance quality and safety in health care.
- Utilize the latest knowledge and skills related to information and technology to enhance patient outcomes.
- Communicate effectively with patients, peers, and all health care providers.
- Utilize the requisite knowledge and skills and technology to practice independently and collaboratively with all health professionals apply the principles of safety and quality improvement.
- Integrated research findings and nursing theory in decision making in evidence-based practice.
- Accept responsibility and accountability for the effectiveness of one's own nursing and midwifery practice and professional growth as a learner, clinician and leader.
- Participate in the advancement of the profession to improve health care for the betterment of the global society.

2. Eligibility for Admissions

B.Sc. Nursing -4 years (Semester system)

- (a) The minimum age for candidates desirous of seeking admission should not be less than 17 years as on 31.12.2025. The maximum age limit for admission shall be 35 years.
- (b) The candidate must have passed Senior School Certificate examination (10+2) of Board of School Education, Haryana or any Board recognized by Central Government / any State Government with subjects of Physics, Chemistry, Biology and English Core/English Elective and should have obtained at least 45% aggregate marks (40% marks for SC/BC/PWBD category) in Physics, Chemistry, Biology & English (PCBE) taken together. However, the candidates should have obtained pass marks in each subject separately. The Candidate(s) who have passed the qualifying exam from state open school recognized from state government and National Institute of Open School (NIOS) recognized from Central Government will also be eligible.
- (c) Candidate should be medically fit.

Post Basic B.Sc. Nursing – 2 years (Annual System)

- (a) The candidate must have passed Senior School Certificate examination (10+2) of Board of School Education, Haryana or any Board recognized by Central Government/Any State Government.

Note: Those who have done Matric / 10+1 in or before 1986, will be eligible for admission.
- (b) Should have passed GNM examination and should be a registered Nurse and Registered Midwife or equivalent with any State Nursing Registration Council.
- (c) Candidate should be medically fit.

3. Number of Seats:

B.Sc. Nursing	:	100 Seats
Post Basic B.Sc. Nursing	:	60 Seats

The number of seats in above said programmes may be increased or decreased subject to final approval of seats from regulatory authorities i.e. Department of Medical Education & Research of Haryana State/ Haryana Nurse and Midwives Council / Indian Nursing Council, New Delhi.

4. Programme Fees:

- i) B.Sc. (Nursing) Rs. 98,000/- per semester *
- ii) Post Basic B.Sc. (Nursing) Rs. 98,000/- per semester*

* In addition to above semester fee the Security/Caution Money/Red Cross Fees/Students Insurance Fees/ Students Welfare Fund etc. , if any, will also be charged as per University rules.

5. Reservation Policy:

The Reservation Policy of the State Government regarding distribution of the seats category-wise will be followed.

Further, for Disabled candidates: 3% Disability reservation to be considered with a disability of loco-motor to the tune of 40% to 50% of the lower extremity and other eligibility criteria with regard to age and qualification will be same as prescribed for each nursing programme.

Colour Blind candidates are eligible provided that colour corrective contact lens and spectacles are worn by such candidates.

The provisions mentioned in Chapter-7, "Distribution and Reservation of Seats" of the University Prospectus 2025-26 will be applicable.

6. How and where to Apply

The candidates are required to apply Online by logging on to www.gjust.ac.in. Candidates are neither required to send any certificate/ document in support of their eligibility nor printout of their Application Form (confirmation page) to the University. In the event of any ineligibility being detected by the University at any stage, their candidature shall stand cancelled automatically and the fee deposited, if any, will be forfeited.

Categories exercised at the time of submission of "Online Application Form" will be final. However, the candidates may opt Multiple options, wherever applicable, for having their categories/ reservation while submitting online Application Form e.g. (i) GEN, EWS, ESM, PH, (ii) SC/Deprived SC, ESM, PH etc. (iii) BC, ESM, PH etc. Therefore, the candidates are advised to fill up the information relating to their category/ reservation in the "Online Application Form" carefully as the same will be used while preparing the merit list.

7. Admit Card:

Admit Card for Entrance Test will be downloaded by the candidates from the website www.gjust.ac.in as per the Online Application Key-Dates of above said programmes and follow the instructions given in the Admit Card. The Admit Card will not be sent by post separately by the University/ Department of Nursing.

8. Conduct of Entrance Test:

B.Sc. Nursing -4 years (Semester system)

Date of Entrance Test as per Scheduled Key Dates 2025-26.

The Medium of Examinations:

The medium of Entrance Test will be English.

Scheme of Examinations

The Entrance Test shall consist of one paper of 3 Hrs. duration. The paper will include objective type questions.

Number of questions and maximum marks:

- (i) There will be a total of 180 objective type questions (in the subject of Physics, Chemistry and Biology (Botany and Zoology)) preferably equally distributed.
- (ii) The paper shall carry a maximum of 180 Marks
- (iii) There will be no negative marking.

Post Basic B.Sc. Nursing – 2 years (Annual System)

Date of Entrance Test: As per Scheduled Key-Dates 2025-26

The Medium of Examinations:

The medium of Entrance Test will be English.

Scheme of Examinations

The Entrance Test shall consist of one paper of 3 Hrs. duration. The paper will include objective type 180 MCQ questions.

Number of questions and maximum marks:

- (i) There will be a total of 180 objective type questions
- (ii) The paper shall carry a maximum of 180 Marks
- (iii) There will be no negative marking.

It is for information of all the candidates that the syllabi for Entrance Tests will be available on the University website: www.gjust.ac.in. All are advised to visit the website for the same. The syllabi for Entrance Tests for above said programmes will be got uploaded by the Chairperson, Department of Nursing.

9. PROCEDURE FOR ADMISSION:

The admission to B.Sc. Nursing and Post Basic B.Sc. Nursing programmes will be made on the basis of merit of entrance test conducted by Guru Jambheshwar University of Science and Technology, Hisar subject to fulfilling the other conditions mentioned in the university prospectus for the session 2025-26.

Further, the Procedure/Criteria for admission, as mentioned in the University Prospectus 2025-26 will also be applicable, wherever applicable.

Tie-Breaking

In case of a tie between two or more candidates having equal Marks/ Merit, in entrance test the inter-se-ranking of such candidates shall be determined as follows:-

For B.Sc. Nursing:

1. A candidate with higher aggregate marks in the respective qualifying examination will be ranked higher.
2. Still if there is a tie then, a candidate older in age will be ranked higher in merit.

3. Still if there is a tie then, alphabetically the one who comes first.

For Post Basic B.Sc. Nursing:

1. A candidate with higher aggregate marks in General Nursing & Midwifery will be ranked higher.
2. Still if there is a tie then, a candidate older in age will be ranked higher in merit.
3. Still if there is a tie then, alphabetically the one who comes first.

10. Display of Entrance Test Result

Entrance Test Result will be uploaded on university website: www.gjust.ac.in as per Scheduled Key Dates 2025-26. It shall be the responsibility of the candidate(s) to remain in touch with the University website/ department of Nursing to ascertain the progress of admission. No separate communication will be sent to the candidate(s) by the University.

11. Seat Matrix (Distribution Chart)

The Seat Matrix (Distribution Chart) for admission to above said programmes for the session 2025-26 will be uploaded on the University web site: www.gjust.ac.in in due course of time.

12. Documents required at the time of Counseling/ Reporting:

All the following original certificates are required at the time of Counseling/reporting:

- (i) Qualifying examinations, i.e. 10th, 12th and GNM etc. as per eligibility of the programme.

The result of qualifying examination is mandatory for admission to above said programmes.

Certificates of 10th class for Date of Birth and 12th class are also required for the purpose of registration etc.

In case of admission to Post Basic B.Sc. Nursing programme, it is mandatory for the candidates to bring their Registration Certificate as GNM in original.

- (ii) Reserved Category (SC/Deprived SC/BCA/BCB/PH (Differently-abled person)/ EWS/ ESM/ FF etc. of Haryana) certificate for Reservation in proper format, if applicable. The specimen formats are given as **Annexure B-I to B-VI and B-X** in the University Prospectus 2025-26.
- (iii) Proper "Family Income Certificate" and / or Affidavit in case of SC/Deprived SC /BC candidates of Haryana seeking any concession/ reservation. The specimen format of Affidavit is given as **Annexure B-IV** in the University Prospectus 2025-26.
- (iv) Proper "Income and Asset Certificate" in case of EWS candidates of Haryana seeking any concession/ reservation. The specimen format is given as **Annexure B-X** in the University Prospectus 2025-26.
- (v) The eligible SC/Deprived SC students will submit the SC Scholarship Form at the time of admission/ deposition of fee, which can be obtained from the office

of the concerned department and the same could also be downloaded from university website www.gjust.ac.in

- (vi) Character Certificate. The specimen format of Character Certificate is given as **Annexure B-VII** in the University Prospectus 2025-26.

For Character Certificate

Candidates, who have recently passed/ appeared in the qualifying examination during 2025, must submit Character Certificate from the Head of the Institution last attended as per specimen given in **Annexure B-VII** in the University Prospectus 2025-26.

OR

Candidates who have passed the qualifying examination as private candidates should submit their Character Certificate duly signed by a First-Class Magistrate.

OR

Candidates who have gap in their academic career after the qualifying examination, must furnish a gap certificate, in the form of affidavit on non-judicial paper or certificate from the employer (if in service) and should also furnish separately the Character Certificate of gap period duly attested by Notary Public.

Scanned copy of the online result/DMC/ Digital Locker will also be accepted.

All the original documents as mentioned at Clause 6.1 of the University Prospectus 2025-26 are required at the time of counseling. In case of admission to Post Basic B.Sc. Nursing programme, it is mandatory for the candidates to bring their Registration Certificate as GNM in original beside other required certificates mentioned in the University Prospectus 2025-26. Personal appearance of candidates with all original documents as mentioned in the University Prospectus 2025-26 shall be compulsory at the time of reporting to the Admission Committee during the counseling. All admissions shall be provisional subject to approval of NOC from DME&R, Haryana and course recognition from Haryana State/ Haryana Nurse and Midwives Council / Indian Nursing Council, New Delhi.

13. SCHEDULE OF COUNSELINGS

FOR B.Sc. Nursing and Post Basic B.Sc. Nursing :

The Counseling Scheduled for admission to above said programmes for the session 2025-26 will be uploaded on the University web site: www.gjust.ac.in in due course of time.

It shall be the responsibility of the candidate(s) to remain in touch with the University website/ department of Nursing to ascertain the progress of admission and to attend the Counseling(s). No separate communication will be sent to the candidate(s) by the University.
