- 1. If ' $\rightarrow$ ' denotes increasing order of intensity, then the meaning of the words [simmer  $\rightarrow$  seethe  $\rightarrow$  smolder] is analogous to [break  $\rightarrow$  raze  $\rightarrow$  \_\_\_\_\_]. Which one of the given options is appropriate to fill the blank?
- (A) obfuscate
- (B) obliterate
- (C) fracture
- (D) fissure

Correct Answer: (B) obliterate

Solution:

Step 1: Understanding the analogy. The given sequence [simmer  $\rightarrow$  see the  $\rightarrow$  smolder] represents an increasing intensity in the description of heat. Similarly, [break  $\rightarrow$  raze  $\rightarrow$  \_\_\_\_\_]

represents an increasing intensity in the context of destruction.

#### Step 2: Analyzing the options.

- Option (A): obfuscate This means to make something unclear or obscure. It is unrelated to the context of destruction.
- Option (B): obliterate This means to completely destroy or wipe out, which corresponds to the most intense level of destruction in the sequence.
- Option (C): fracture This refers to a crack or breaking of something, which is less intense than "raze."
- Option (D): fissure This refers to a narrow crack or opening, which is also less intense than "raze."

Conclusion: The correct word to complete the sequence is **obliterate**, as it signifies the highest level of destruction, analogous to "smolder" in the given analogy.

#### 2. In a locality, the houses are numbered in the following way:

The house-numbers on one side of a road are consecutive odd integers starting from 301, while the house-numbers on the other side of the road are consecutive even numbers starting from 302. The total number of houses is the same on both sides of the road.

If the difference of the sum of the house-numbers between the two sides of the road is 27, then the number of houses on each side of the road is:

- (A) 27
- (B) 52
- (C) 54
- (D) 26

Correct Answer: (A) 27

#### Solution:

Step 1: Represent the sequence of house numbers. The house numbers on one side of the road are consecutive odd numbers starting from 301:

$$301, 303, 305, \dots$$

This sequence is an arithmetic progression (AP) with the first term  $a_1 = 301$  and common difference d = 2.

Similarly, the house numbers on the other side of the road are consecutive even numbers starting from 302:

$$302, 304, 306, \dots$$

This sequence is an arithmetic progression (AP) with the first term  $a_2 = 302$  and common difference d = 2.

Let the number of houses on each side of the road be n.

Step 2: Calculate the sum of house numbers on each side. The sum of an AP is given by:

$$S = \frac{n}{2} [2a + (n-1)d]$$

For the odd-numbered side:

$$S_{\text{odd}} = \frac{n}{2} [2(301) + (n-1)(2)] = \frac{n}{2} [602 + 2n - 2] = \frac{n}{2} (600 + 2n) = n(300 + n)$$

For the even-numbered side:

$$S_{\text{even}} = \frac{n}{2} [2(302) + (n-1)(2)] = \frac{n}{2} [604 + 2n - 2] = \frac{n}{2} (602 + 2n) = n(301 + n)$$

Step 3: Difference between the sums. The difference between the sums is given as:

$$S_{\text{even}} - S_{\text{odd}} = 27$$

Substituting the values:

$$n(301 + n) - n(300 + n) = 27$$
$$n \cdot 301 + n^2 - n \cdot 300 - n^2 = 27$$
$$n = 27$$

Conclusion: The number of houses on each side of the road is 27.

Thus, the correct relationship is:

Step 1: Identify the pattern in the sequence. The given sequence is:

Observing the numbers, they are of the form:

 $2^n - 1$ , where n is a positive integer.

Step 2: Verify each term.

$$3 = 2^{2} - 1,$$

$$7 = 2^{3} - 1,$$

$$15 = 2^{4} - 1,$$

$$x = 2^{5} - 1 = 31,$$

$$63 = 2^{6} - 1,$$

$$127 = 2^{7} - 1,$$

$$255 = 2^{8} - 1.$$

Step 3: Conclusion. The value of x that satisfies the sequence is:

$$x = 31.$$

Correct Answer: (C) 50

**Solution:** 

- Step 1: Understanding the problem. The second-hand and the minute-hand of a clock cross each other 60 times in one hour. Each crossing corresponds to the time when the two hands align at the same position.
- Step 2: Total crossings in 50 minutes. The given time interval is from 12:05:00 to 12:55:00, which is 50 minutes. The number of crossings in one minute is:

$$\frac{60\,\mathrm{crossings}}{60\,\mathrm{minutes}} = 1\,\mathrm{crossing}\,\,\mathrm{per}\,\,\mathrm{minute}.$$

Thus, in 50 minutes, the total number of crossings is:

50 crossings.

**Step 3: Conclusion.** The second-hand and the minute-hand will cross each other exactly 50 times during the time interval 12:05:00 to 12:55:00.

Step 1: Analyze the grammatical structure. Each blank requires a word that fits both grammatically and contextually. The singular subject "athletics" matches with the verb "holds" for (i). Similarly, the singular subject "crowd" matches with "waits" for (ii).

Step 2: Examine the actions described. The phrase "Six cross-steps \_\_\_\_ (iii)" describes the culmination of a sequence, requiring the base verb "culminate" (plural form for "steps"). Lastly, "his body \_\_\_\_ (iv)" describes a rotational action, appropriately described by "pivots."

Step 3: Verify correctness of selected option. The combination in Option (D): "holds, waits, culminate, pivots" satisfies all grammatical and contextual requirements.

7. Three distinct sets of indistinguishable twins are to be seated at a circular table that has 8 identical chairs. Unique seating arrangements are defined by the relative positions of the people.

How many unique seating arrangements are possible such that each person is sitting next to their twin?

- (A) 12
- (B) 14
- (C) 10
- (D) 28

Correct Answer: (A) 12

**Solution:** 

#### Step 1: Understanding the problem.

The problem involves seating three distinct sets of twins (A, B, C) around a circular table such that: 1. Each twin is seated next to their pair. 2. The arrangement is defined by the relative positions, making the seating circular.

#### Step 2: Represent each twin as a pair.

Each twin pair can be treated as a single unit (A, B, C), which leaves us with three distinct units to arrange around the circular table.

#### Step 3: Arrangements of three units in a circular table.

For a circular table, the number of unique arrangements of n distinct objects is given by:

$$(n-1)!$$

For three twin pairs:

$$(3-1)! = 2! = 2$$

Thus, there are 2 ways to arrange the three pairs around the table.

#### Step 4: Arrangements within each pair.

Within each pair (A, B, C), the twins can be seated in 2 ways (e.g.,  $A_1A_2$  or  $A_2A_1$ ). Since there are three pairs, the total number of arrangements is:

$$2 \times 2 \times 2 = 8$$

### Step 5: Total number of unique arrangements.

The total number of unique arrangements is the product of the two results above:

$$2 \times 8 = 16$$
.

However, due to the identical nature of the table (rotational symmetry), the final count is divided by 2 (as rotations result in identical arrangements). Thus:

$$\frac{16}{2} = 12.$$

#### Conclusion.

The total number of unique seating arrangements is:

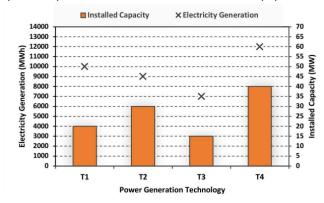

# Q8. The chart given below compares the Installed Capacity (MW) of four power generation technologies, T1, T2, T3, and T4, and their Electricity Generation (MWh) in a time of 1000 hours (h).



The Capacity Factor of a power generation technology is:

Capacity Factor = 
$$\frac{\text{Electricity Generation (MWh)}}{\text{Installed Capacity (MW)} \times 1000(h)}$$

Which one of the given technologies has the highest Capacity Factor?

- (A) T1
- (B) T2
- (C) T3
- (D) T4

Correct Answer: (A) T1

**Solution:** 

Step 1: Using the given formula, compute the Capacity Factor for each technology:

Capacity Factor = 
$$\frac{\text{Electricity Generation (MWh)}}{\text{Installed Capacity (MW)} \times 1000}$$

For each technology: - T1:

Capacity Factor = 
$$\frac{5000}{10 \times 1000} = 0.5 = 50\%$$
.

- T2:

Capacity Factor = 
$$\frac{7000}{20 \times 1000} = 0.35 = 35\%$$
.

- T3:

Capacity Factor = 
$$\frac{4000}{10 \times 1000} = 0.4 = 40\%$$
.

- T4:

Capacity Factor = 
$$\frac{10000}{40 \times 1000} = 0.25 = 25\%$$
.

**Step 2:** Comparing the Capacity Factors: The highest Capacity Factor is 50%, which corresponds to technology T1.

Conclusion: The technology with the highest Capacity Factor is T1.

Rule: The number in a cell represents the count of crosses (X) around its immediate neighboring cells (left, right, top, bottom, diagonals). As per this rule, the maximum number of crosses possible in the empty column is:

Correct Answer: (C) 2

Solution:

Step 1: Analyze the rules of the problem. Each number in the grid specifies how many X's (crosses) are in its immediate vicinity, including diagonal, vertical, and horizontal neighbors.

Step 2: Determine constraints for the empty column. The fourth column is currently empty. To maximize the number of X's in this column, the following conditions must be met for the cells in the first three columns:

- (1,3) = 2: This cell already has two neighboring X's in (2,2) and (2,3). Thus, (1,4) cannot be X. - (2,3) = 3: This cell has one neighboring X at (2,2) and requires two additional X's. We place X at (2,4) and (3,4). - (3,3) = 4: This cell already has two neighboring X's at (3,2) and (4,3). We add two more X's at (3,4) and (4,4). Note: (3,4) is already X, so we only add X at (4,4).

Step 3: Verify placement of X's in the fourth column. The final arrangement for the fourth column is as follows:

 $\begin{bmatrix} X \\ X \\ X \end{bmatrix}$ 

There are 2 crosses (X's) in the fourth column.

Step 4: Conclusion. The maximum number of X's in the empty column is 2.

**Solution:**

angle at the Moon. The angle  $\angle$ Moon-Earth-Sun is given as 89.85°. Using trigonometric relationships in this triangle, we can compute the ratio of the Earth-Sun distance ( $D_{\rm ES}$ ) to the Earth-Moon distance ( $D_{\rm EM}$ ).

#### Step 2: Using the tangent function.

From the given geometry, we have:

$$\tan(\angle \text{Moon-Earth-Sun}) = \frac{D_{\text{ES}}}{D_{\text{EM}}}.$$

Given  $\angle$ Moon-Earth-Sun = 89.85°, we compute:

$$\tan(89.85^{\circ}).$$

**Step 4: Conclusion.** The correct sequence is given in Option (C).

Also, the punctuation in the second sentence is flawed. - Option (C): The placement of punctuation marks outside the quotation marks is incorrect. - Option (D): The reporting clause is punctuated incorrectly, and the sentence does not use commas correctly for clarity.

**Conclusion:** Option (B) is the only one that follows standard punctuation rules, making it the correct answer.
