**Re: Audit of Summer Placement Report for the batch 2025-27 of Post-Graduate Programme in Food & Agri Business Management**

Consequently, as per the institute's advice, all the students have been categorized under 'Domestic Locations/PAN India'.
4. The acceptance of offers has been established through written communication from the students.



5. We have only audited the data related to location, function & stipend in the Placement Report and not the placement overview section or any additional information presented in the report.
6. Wherever information was missing reasonable assumptions have been made.

## Overview

The PGP-FABM (Post-Graduate Programme in Food & Agribusiness Management) summer placement process for the batch of 2025-27 was completed successfully on 3<sup>rd</sup> November 2025. The process was carried out in a hybrid mode. From April - June 2026, 46 students from the FABM Class of 2025-27 will be engaged in their summer internship. The successful completion of the placement process within a day is a testament to the Institute's high-quality learning experience and the robust placement process that provides adequate flexibility to both recruiters and students.

The FABM students looking for summer placements were well-received by the industry and 35 companies participated in the placement process. The placements witnessed a balance of roles from all the sectors like Consulting, Agri Inputs, Agri-Tech, FMCG, Food Processing, ESG Consulting, Environment & Energy, and other sectors.

The placement process witnessed regular recruiters who reaffirmed their confidence in the program such as Godrej Agrovet, Ernst & Young (EY), Bayer, UPL, Nestle, PepsiCo, Marico, United Breweries, DeHaat, PI Industries, DCM Shriram, Varaha, AgVaya, AMUL, Everest Instruments, Banas Dairy, ITC etc. Many new recruiters also showed a keen interest in the batch, which is visible by the participation of industry giants like Sundrop Brands, Umami Bioworks, Bonn Groups, Drum Foods, FIL Industries etc.
