### **INFORMATION BROUCHER FOR DOCTOR OF PHILOSOPHY (Ph.D.) Admission - 2025**

#### **Eligibility criteria for admission to Ph. D. Programme :**

For admission to the Ph. D. programme in a subject under any Faculty the applicant shall fulfill the following criteria:

#### **1 Faculty of Medicine:**

A candidate who has passed MD/MS/D.M/M.Ch. Degree examination in the concerned subject from an Institute which is recognized by the Medical Council of India/ National Medical Council.

**OR**

A Candidate having Diploma in National Board (DNB) qualification in the concerned subject

**OR**

Candidate having passed M. Sc. (Medical) Degree examination from a recognized University in the subject of Anatomy, Physiology, Biochemistry, Pharmacology and Microbiology with a minimum of 55% marks in aggregate.

**OR**

A candidate having Pharm. D. which is recognized by Pharmacy Council of India.

#### **2 Faculty of Dentistry:**

A candidate who has passed a Master in Dental Surgery (MDS) Degree examination in the concerned subject from an Institute which is recognized by the Dental Council of India.

#### **3 Faculty of Science and Technology:**

A candidate having passed Master Degree examination from a recognized University, i.e., (M.Sc. or M. Tech.) Degree from any branch of Science related to Biotechnology, Bioinformatics, such as Chemistry /Biology / Life Sciences / Microbiology/ Biotechnology/ Bioinformatics / Plant environmental/Pharmacy/ Environmental/ Agriculture Science/ Pharmaceutical Sciences etc. with a minimum of 55% marks in aggregate.

#### **Computer Science and Engineering**

The candidate must have completed masters degree( ME/MTech.) from a recognized university. The acceptable disciplines include: Computer Engineering /Information Technology/Computer Science and Engineering/Artificial Intelligence and Data Science/ Electronics and Telecommunication

Minimum Percentage: The candidate should have obtained a minimum of 55% marks (or equivalent) in aggregate in their masters degree examinations.

**OR**

Candidates who have completed:

A 1-year/2-semester master's degree programme after a 4-year/ 8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed

**OR**

equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

Provided that a candidate seeking admission after a 4 – year / 8 - semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non creamy layer) Differently –abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

#### **4 Faculty of Nursing:**

- 1 A candidate who has passed a Post Graduate degree in Nursing recognized by Council with 3 years teaching or Clinical experience after M.Sc. (Nursing) for enrolment for Ph.D. in Nursing (part-time) under Faculty of Nursing in the respective University.
- 2 The candidate should have passed M.Sc. (Nursing) with a minimum of 60% marks.
- 3 Working in Teaching Institution / Hospital / Community Centre / Nursing Department within the University jurisdiction.

#### **5 Faculty of Allied Health Sciences:**

- 1 A candidate who has passed a Master of Physiotherapy Degree examination (MPT) from a recognized University with a minimum of 55 % marks in aggregate.
- 2 A candidate having passed Master of Optometry Degree examination from a recognized University with a minimum of 55% marks in aggregate.
- 3 A candidate who has passed full time two years Post Graduate Degree in the respective and or related Allied Health Sciences domain from a recognized University.

**OR**

(1) Candidates who have completed:

A 1-year/2-semester master's degree programme after a 4-year/ 8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate equivalent grade in a point scale wherever grading system is followed

**OR**

equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or

incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

Provided that a candidate seeking admission after a 4 – year / 8 - semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non creamy layer} Differently –Abled, Economically Weaker Sectio (EWS) and other categories of candidates as per the decision of the Commission from time to time.

## **6 Faculty of Ayurved:**

A candidate who has passed a Master Degree examination in Ayurved from a recognized Institute which is recognized by the Central Council of Indian Medicine.

- (1) The Ph. D. Programme shall be full-time research programme.
- (2) The Ph. D. Programme shall not be recognised in case if :
  - (a) The Ph. D. scholar and the Ph. D. are at different places during the research period.
  - (b) The working place of Ph. D. scholar and the research place registered for Ph. D. are different.

## **7 Faculty of Homoeopathy**

A candidate who has passed a Master Degree examination in Homoeopathy from a recognized Institute which is recognized by the Central Council of Homoeopathy.

## **8 Faculty of Commerce and Management:**

A candidate having passed Master Degree Examination in Management or Business Administration or Management related subjects with a minimum of 55 % marks from a recognized University in aggregate. The fellow members of the Institute of Chartered Accountants and/or Institute of Cost & Works Accountants of India or Institute of Company Secretaries of India shall be eligible, provided that they possess a Bachelor Degree of any statutory University with a minimum 55% marks in aggregate. Such candidate should have at least 5 years professional experience.

## **9 Ph. D. in Genetics:**

A candidate having passed Master Degree examination from a recognized University, i.e., M.Sc. Degree from any branch of Life Sciences and Biotechnology with a minimum of 55% marks in aggregate.

A candidate who have applied from Life Science will get Ph. D. Degree in Genetics from Faculty of Science and Technology.

**OR**

A candidate who have passed P G (MD/MS) Degree examination in the subject of Anatomy, Physiology, Biochemistry, Pathology, Medicine and Pediatric (Health Science subject) from an Institute which is recognized by the Medical Council of India/ National Medical Council.

A candidate who have applied from Health Sciences subject category will get the Ph. D. Degree in Genetics from Faculty of Medicine.

## **10 Inter-Disciplinary Research :**

Application for research in inter-disciplinary areas and from applicants belonging to a faculty or a subject other than the faculty or subject in which the research is proposed to be done, shall be considered on the basis of the proven ability and aptitude for researcher as evidenced by his/her publications/ research work/academics.

A relaxation of 5% of marks from 55% to 50% or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non- creamy layer) differently-abled and other categories of candidates as per the decision of the Vidyapeeth from time to time.

### **11 M. Phil. candidates**

A candidate who have cleared the M. Phil. Course work with at least 55% marks in aggregate of its equivalent grade 'B' in the UGC-7 point scale or an its equivalent grade in a point scale, wherever, grading system is followed and successfully completing M. Phil. Degree shall be eligible to proceed to do research work relating the Ph. D. in the same Institution.

Candidate possessing a Degree considered equivalent to M. Phil. Degree of an Indian Institution, from a Foreign Educational accredited by an Assessment and Accreditation Agency which approved, recognized or authorized by an authority, established authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational Institutions, shall be eligible for admission to Ph.D. Programme.

### **International students**

#### **Eligibility**

Only nationals of countries other than India can apply in the international student category. At the time of admission, the applicants for the PhD programme must have completed a 4-year undergraduate degree or a master's degree from an institution located outside India.

Candidate has to obtain an equivalence certificate from the competent authority in India (UGC) for confirmation of admission to the Ph.D. program at Dr. D.Y. Patil Vidyapeeth, Pune.

**\*\* Overseas Citizen of India (OCI) students** who have obtained their qualifying degrees ( 10+2 or equivalent, Bachelors, and Masters) in India can apply through the regular departmental admission portal.

#### **Application process**

- Online application via DPU Ph.D. admission portal. (web address)
- Email of the application to "info@dpu.edu.in".
- 'Study in India' Programme launched by the Ministry of Education, Government of India.

The email must include Cover letter, CV, research statement, scan of information pages of passport, transcripts and three letters of recommendation. Do indicate your nationality and describe your academic track record in your CV. In your cover letter, indicate the Department of your interest along with name potential Ph.D. supervisor.

#### **Selection process**

Selection will be based on pre-screening, followed by an interview process with multiple rounds. The process will be defined by individual departments and communicated to the applicants in advance. Where possible, interviews will be conducted by video conference.

### **PROCEDURE FOR ADMISSION:**

A candidate shall submit online application to the Registrar in the prescribed format available on Vidyapeeth website together with the processing fee, to be paid online within the stipulated time furnishing the following information:-

Those who are working should produce NOC from the HOD as well as Head of Institute concerned and should be enclosed **(Appendix-A)**

Incomplete online application received by the Vidyapeeth shall be rejected and no correspondence shall be entertained by the Vidyapeeth.

The Entrance Test shall be on line mode proctor based consist of two papers and personal interview as viva voce on research proposal

There shall be separate sub-sections for each Specialization such as Medical, Dental, Biotechnology & Bioinformatics, Nursing, Physiotherapy, Ayurved, Homoeopathy, Management etc.

The qualifying criteria of securing marks for the Ph. D. Entrance Test shall be minimum 50% aggregate marks for the candidates belonging to open Category and minimum 45% aggregate Marks for the candidate belonging to the reserved category in the Entrance Test, to be eligible for the admission.

**\* For Nursing Faculty: Entrance Test will be of 100 marks**

- Entrance test marks obtained out of 90 marks. (Minimum weightage pass marks for entrance will be 60% of 90 i.e. 54).
- 5 marks for candidates possessing M. Phil. in Nursing.
- 5 marks weightage for publications.

Nursing in which qualifying criteria of securing marks for the Ph.D. Entrance Test shall be minimum 60% aggregate marks for the candidates to be eligible for the admission.

A relaxation of 5% of marks from 55% to 50% or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non- creamy layer) differently-abled and other categories of candidates as per the decision of the Vidyapeeth from time to time.

**Exemption :** will be for candidate who have qualified UGC/CSIR(JRF)/SLET/NET/SET/AYUSH Teacher Fellowship Holder / Candidates already holding M. Phil. degree and admitted to the Ph.D. Programme or those who have already completed the course work in M. Phil. and have been permitted to proceed to the Ph.D. course. However, candidate has to appear for the Paper-III (Personal Interview/viva voce on Research proposal etc. )

The registration of candidates for Ph.D. Degree shall be considered as provisional till the candidate successfully completes Pre-Ph.D. theory course work of one semester duration.

#### **Pre- Ph. D. COURSE :**

There will be full time Pre-Ph.D. course of 6 months which is compulsory for all the candidates. At the end of 6 months after provisional registration and on completion of such course of Instruction there shall be a Pre-Ph.D. examination. Candidate has to score minimum of 50% marks in each

paper and 55% marks in aggregate of to be considered eligible to proceed with the research work and 50% marks in the case of SC/ST/OBC (non-creamy layer) candidate.

The candidate has to pass the Pre-Ph.D. examination within two attempts. The Registration for the course will be confirmed only when he/she passes the Pre-Ph.D. examination. If he/she fails in both the attempts, provisional registration shall be cancelled by the Vidyapeeth and no further communication in this regard shall be entertained.

#### **\* For Nursing Faculty:**

The provisional registration of the candidate shall be confirmed only after he/she has passed the Pre-Ph.D. examination which shall be conducted after the completion of one year from the date of provisional registration of the candidate. The scheme of Pre-Ph.D. examination is as follows :

**Note:** 70% attendance is compulsory for contact hours. If the student does not have 70%, he/she will not be allowed to appear for the Pre-Ph.D. examination, however they have to make up for the same next academic year. The syllabi for both the papers shall be as prescribed by the Indian Nursing Council.

**Scope for changing the research topic:** The research topic can be changed within one year.



**REGISTRATION:**

Ph. D. Programme shall be for a minimum duration of three years, including Course work and a maximum of six years. The actual term of selected Ph. D. scholar shall be deemed to start from the date of provisional Registration.

However, the same may be further extended for maximum periods of two years, being one year at a time, after submission of valid justification by the Ph. D. scholar and by paying prescribed fees as determined by the Vidyapeeth, from time to time. After the extended periods, no further extension shall be granted, and if the Ph. D. scholar wishes to pursue the Ph. D. course thereafter, then he shall have to register again as fresh candidate, following the due procedure, including the Ph. D. Entrance Test.

The women candidates and Persons with Disability (more than 40% disability) may be allowed a relaxation of two years for Ph.D. in the maximum duration. In addition, the women candidates may be provided Maternity Leave/Child Care Leave once in the entire duration of Ph.D. for up to 240 days.

\* **For Nursing Faculty:** Full time research scholars are those who register for Ph.D. on full time basis and are not employed anywhere. Part time research scholars are those who are presently employed in any College/School/Hospital/Institute/Nursing department within the University jurisdiction.

### Vidyapeeth Eligibility & Registration Fee (One-time Fee)

Fifteen Percent (15%) of the Annual Tuition Fee, payable for the first year only, shall be paid online by the student separately at the time of filing in the Eligibility Application as Vidyapeeth Eligibility and Registration Fee.

### Pre-Ph.D. Examination Fee :

In addition to the above fees, the student shall pay the Pre-Ph. D. Examination Fee as prescribed by the Vidyapeeth from time to time.

### Tuition Fee :

The first installment will have to be paid within 15 days from the date of provisional admission. The successive installments will have to be paid within a month from the date of completion of each year. In case of failure to pay the prescribed fee, a late fee, as prescribed by the Vidyapeeth from the due date of payment shall be charged.

## Integrated P. G. - Ph. D. Programme Admissions - 2025

Vidyapeeth has started Integrated P. G. – Ph. D. Programme under the Faculties of Medicine, Dentistry, Ayurved and Homoeopathy. Students who have been admitted or will be admitted at Dr. D. Y.
