### Minimum Qualification:

\* 2 year PUC or equivalent course with 45% Aggregate Marks (OBC 42%, SC/ST 40%).

**Age Limit:** Maximum age for seeking admission is limited to 20 years (born on or after 04-05-2006) in case of General Category of applicants and to 22 years (born on or after 04-05-2004) in the case of applicants from SC, ST and Other Backward Class.

**Selection Procedure:** Admissions to the above programmes are based on admission test designed to decide the candidate's skill in Comprehension Communication, Arithmetic and reasoning ability and aptitude for Legal learning.

\* Government rules relating to reservations apply.
