Online Registration and CAP Round -3 Schedule for BPTH/BOTH/BASLP/B P&O/BNYS (Group C) courses A.Y.2025-26

In continuation of the Admission Process for BPTH/BOTH/BASLP/B P&O/BNYS (Group C) Courses for Academic Year 2025-26, it is hereby notified that the Centralised Admission Process (CAP) Round - 2 has been completed on 11/10/2025.

There are few seats remaining vacant after completion of CAP Round -2. State CET Cell, Maharashtra State, has decided to conduct CAP Round - 3 to fill these vacant seats for BPTH/BOTH/BASLP/B P&O/BNYS (Group C) courses as per the schedule given below:

The above schedule is subject change as per the direction of various authorities like MCC / AACCC / Central Government / State Government / Hon'ble Court.

Important Instructions:

- 1. Candidates who have already registered need not register again.
- 2. Candidates who have Cancelled/Not Join allotted a seat in BPTH/BOTH/BASLP/BP&O/BNYS (Group C) CAP Round 2 have to Unlock Application and Submit form once again and make payment from candidate login.
- 3. The choices filled by candidates for CAP Round 2 will be treated as null and void. All candidates participating in CAP Round 3 must fill fresh choices (preferences) for this round.
- 4. Candidates must complete registration and upload all the requisite original scanned documents within the stipulated schedule.
- 5. Candidate registered during this phase will not be considered for MBBS/BDS (Group A) & BAMS/BHMS/BUMS (Group B) courses as the merit list for these courses is already published for CAP-3 and subsequent round(s).
- 6. Candidate allotted a seat in AIQ Round-3 of MBBS/BDS & AYUSH will not be considered for CAP Round -3 of Allied courses for State counseling.
- 7. Candidate joined seat of CAP Round 3 of MBBS/BDS (Group A) & BAMS/BHMS/BUMS (Group B) will not be considered for CAP Round -3 of Group C for State Counseling.
- 8. It is mandatory to join the allotted seat of CAP Round -3. Candidates who are allotted a seat in CAP Round-3 will not be considered for subsequent rounds irrespective of whether they join or do not join to the allotted seat of CAP Round 3.
- 9. Candidates should also ascertain her/his eligibility for admission to the various courses before filling up the registration form.
- 10. PWD candidates should have claimed the quota at the time of NEET. They should submit Online PWD certificate issued by any one of the 16 boards.
- 11. As per G.R. of General Administration Department ROD-4019/C.R 31/ 16- A, dated 12 February 2019 and Government Resolution no. MED-1018/C.R 37/19/Edu- 2, dated 07th March, 2019. "EWS" means Economically Weaker Section, include persons who are not covered under the scheme of reservation for SC, ST, DT-A, NT-B, NT-C, NT-D, OBC (Inculding SBC) & SEBC.
- 12. Candidates belonging to reservation category must claim so in the application form before submitting the same.
- 13. Any claim for converting from Open/General category to reserved category after submission of application form and payment of fees shall not be entertained.

- 14. NRI candidate should register on <u>Foreign Candidate Registration Portal</u> **before 29/10/2025** for verification of candidate's eligibility. The subsequent schedule will be as above.
- 15. NRI candidates should note that they are eligible only for 15% Institute Quota as permerit.

The candidates are advised to visit State CET Cell official website i.e.www.mahacet.org, from time to time, for updates.
