### **!** Eligibility of Candidates for CAP online Stray Vacancy round:

- 1. NEET UG 2025 qualified candidates who have registered but not been allotted a seat till CAP Round 3.
- 2. Candidate should be eligible as per clause 4 of the information brochure.

#### ❖ Non Eligibility for CAP online Stray Vacancy Round :

- 1. Candidates who have joined seat in Round 1, Round 2 and/or allotted a seat in CAP Round 3.
- 2. Candidates who have joined seat in Round 1, Round 2 and/or allotted a seat in CAP Round 3 of All India Quota seats .
- 3. Candidates who were allotted a seat in Round 3 but failed to join the allotted seat.

#### Note:

- 1. No new registration will be done for this CAP online Stray Vacancy Round.
- 2. Candidate will have to fill fresh choices for CAP Online Stray Vacancy. Choice filled during Round 3 will be null and void. The choice filled for online stray vacancy round 1 will be used for subsequent stray vacancy round (if any)
- 3. It is mandatory to join the seat allotted during Online Stray Vacancy Round hence candidates are advised to be vigilant and fill only those choices where they intend to take admission.
