## AIPHDCET- Eligibility Criteria

The candidates who will be having four year degree qualification in accordance with the Ph.D. Regulations 2022 dated 7<sup>th</sup> November 2022 are eligible to apply. It will be applicable to Faculty of Engineering and Technology, Faculty of Pharmaceutical Sciences, Faculty of Commerce & Management and Faculty of Allied Health Sciences.

The applicant shall have secured **55%** or more marks in masters or its equivalent CGPA grade for general category and **5% less for reserve category**. The candidate seeking admission after a 4-year/8semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

### Eligibility of International Candidates for Admission to the Doctoral Program (Ph.D.)

1. Any candidate who has passed Post Graduate Degree (Master's Degree) Examination of the Statutory Foreign University or an examination recognized as equivalent there to recognized as equivalent by the Association of Indian Universities (AIU) in India or a professional degree declared equivalent to the Master's Degree by the corresponding statutory regulatory body in the concerned/relevant subject with **at least 55% marks in aggregate or its equivalent Grade Point Average (GPA)**.

- Equivalence certificate issued by the AIU for PG degree and marks for credit.
