[#] M.Sc. Life Sciences (#): M.Sc. Life Sciences is a specific degree and no other degree shall be considered equivalent to same for eligibility for a particular seat where M.Sc. Life Sciences is mentioned for eligibility.

Only 02 AIIMS Rishikesh Fellowships (Stipend) are available for meritorious students and will be awarded as per Institute rules. Decision regarding award of institutional fellowship will be decided by IRRB as per merit in entrance exam and will be considered final.

Important Notes for candidates:

- 1. Candidates can apply for PhD in one department.
- 2. Eligibility will only be for seats in the department and project that they have applied for.
- 3. Seats will be allocated in order of their merit in the exam.
- 4. Successful candidates will be subjected to eligibility criteria of respective Project before admission.
- 5. PhD Scholars are required to make their own arrangements for stay at their own expenses during the period of their PhD Course.
- 6. They are also required to identify source of funding support for their research work, as Institute is not bound to support PhD Scholar (External) for their stay/salary/ research funding support.
- 7. The decision of Institutional Research Review board (IRRB) will be considered final in all matters pertaining to the PhD course.
- 8. Candidates who are allotted a seat but do not join or resign after joining, will NOT be eligible for any additional rounds of seat allocation

III. ELIGIBILITY CRITERIA FOR ADMISSION TO Ph.D. COURSE:

A. A candidate seeking admission to course of study leading to award of a Degree of Doctor of Philosophy must possess at least one of the following qualifications from a recognized University/Institute.

a. Degrees and eligibility for Course for medical candidates:

- 1. MBBS degree or equivalent with minimum of 55% aggregate marks or equivalent percentile in professional examinations.
- 2. MD/MS/MDS/DM/MCH in subject concerned or Diplomat of National Board of examinations or equivalent degree recognized by MCI/DCI
- 3. Masters degree after BAMS, BHMS and BNYS will be eligible for Ph.D. in AYUSH.
- 4. Minimum of 55% marks or equivalent in last eligibility examination qualified.
- **b. Nursing Qualification:** Candidates holding M.Sc. degree with minimum 55% aggregate marks or equivalent percentile in Nursing Speciality will also be eligible for Ph. D admission in College of Nursing.

c. Degrees and eligibility for Course for non-medical candidates:

- 1. Master degree (02-year course) awarded by Indian University or equivalent in subject as per requirement of project.
- 2. Candidates holding M.Sc. (other than M.Sc. Nursing), M. Biotech /M. Tech degree / M Com/ MBA / MPH will be eligible for non-medical qualification category.
- 3. Candidate possessing Master Degree through distance learning course shall not be eligible.
- 4. Minimum of 55% marks or equivalent in last eligibility examination qualified.

NOTE: - A relaxation of 5% may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently abled and female candidates.

B. Eligibility criteria for External Candidates in permanent employment:

- Candidates who are permanent employees of external Institutions (Central Govt/ Semi Govt/ Autonomous organization) should submit application through proper channel. i.e., employer. They will be required to submit a 'No Objection Certificate" from their employer/Head of Institute.
- In addition, such Candidates will have to provide a certificate at time of joining from employer stating that in event of selection to PhD course, Candidate will be granted a minimum period of 03-year study leave with full pay and permission to work at AIIMS Rishikesh to pursue full time PhD Course.

C. Eligibility criteria for In-service- Candidates from AIIMS Rishikesh

For In-service Medical Candidates

- 1. Members of the medical faculty can apply for registration to Ph.D. course as In-service candidate. He/She will be exempted from appearing in the entrance examination.
- 2. The individual should be a regular employee of the institute and should have rendered a minimum of two years of continuous service at the institute.
- 3. The individual should have minimum of 5 years of active service left in the institute at the time of application.
- 4. The medical faculty member should have at least 3 original research publications (not case reports) during the last three years immediately preceding the date of his/her application either as a first author or as a communicating author in a peer reviewed journal.
- 5. The candidate will be considered as In-service candidate provided that the Head of the Department should certify that the work of the department will not suffer and no additional staff will be asked for.
- 6. The candidate seeking admission under this category will have to identify a faculty member in the same department (senior to the candidate) who is willing to be the chief-guide of the candidate. The candidate should submit a letter of acceptance/undertaking from the concerned faculty member in this regard.

For In-service Non-Medical Candidates

- 1. The individual should be a regular employee of the institute and should have rendered a minimum of five years of continuous service at the institute.
- 2. He/She should fulfill all the eligibility criteria for the Ph.D. course, and will appear in the entrance examination and must score minimum of 50% marks.
- 3. The individual should have 5 years of active service remaining in the institute.
- 4. The candidate should have a proven track record of active involvement in research / academic activities of the department. He/she should possess good written and verbal communication skills in English language to be certified by HOD/Chief of Center.
- 5. The candidate should have at least 3 original research publications (not case reports) during the last three years immediately preceding the date of his/her application either as a first author or as a communicating author in a peer reviewed journal.
- 6. The candidate will be considered as in-service candidate provided that the Head of the Department should certify that the work of the department will not suffer and no additional

- staff will be asked for.
- 7. The candidate seeking admission under this category will have to identify a faculty member in the institute who is willing to be the chief-guide of the candidate. The candidate should submit a letter of acceptance/undertaking from the concerned faculty member in this regard.

Note:

- 1. DM, MCh, PDCC candidates and others pursuing a full time academic course at AIIMS Rishikesh cannot apply for a Ph.D. programme.
- 2. If a faculty is registered as a guide of a Ph.D. scholar, he/she will NOT be eligible to apply for Ph.D. course as a Ph.D. scholar until submission of thesis work by research scholar under him/her.
- 3. Any faculty pursuing Ph.D. course himself/herself is NOT allowed to guide a student.
- 4. All In-service candidates should clarify the latest rules and regulations from Ph.D. Cell, AIIMS Rishikesh.

D. Eligibility criteria for Transfer for PhD credit in case of re-location

In case of re-location of PhD scholar due to marriage or otherwise, research period, and research data shall be allowed to be transferred to AIIMS Rishikesh, subject to the condition, that Research Scholar has either joined as employee/ on deputation and has cleared entrance exam (Stage I and Stage II) conducted by AIIMS, Rishikesh and is willing to enroll as a full time PhD Research Scholar. Scholar will give due credit to parent guide and previous Institution for part of research already done.

IV. DURATION OF COURSE:

- i. Duration of course for all candidates will commence from date of joining (provisional registration) to submission of final thesis to exam cell for evaluation.
- ii. PhD course will be full time for all external candidates, including those with sponsorship.
- iii. Minimum Duration: Shall be for a minimum period of 3 years including course work.
- iv. Maximum Duration: Shall be for a period of 6 years.

V. METHOD OF SELECTION:

Entrance to PhD Course will be based on merit scores based on following evaluations. All candidates except in service medical faculty of AIIMS Rishikesh will have to appear in three stages of entrance examination:

A. <u>Stage I</u>: **30 Marks** (30 MCQs of 1 Mark each) Aptitude related MCQs covering English (Written and verbal skills), Biostatistics, Research Methodology, Cell Biology, Lab Technology etc.

<u>Stage II</u>: **40 Marks** (40 MCQs of 1 Mark each) Subject related theory based comprising Multiple Choice Questions (MCQs) of MD/MS/MDS/M.Sc. Entrance level.

Total Marks (Stage I + II): 70 (30+40)
Total Duration (Stage I + II): 90 Minutes

Marking in Stage I & II:

Each correct (MCQ) answer will be awarded 1 mark. More than one answer will be treated as wrong answer. Zero mark will be given for wrong answer, questions not answered or marked for review.

Eligibility for Stage-III: Candidates must score at least 35 marks in Stages I and II (Combined) to be eligible for Stage III. Candidates who do not fulfill the criteria to qualify for stage III will not be eligible for selection.

B. **Special weightage:**

i. Medical / Dental/ Nursing candidates:

- 10 marks will be added to the total score of Stages I and II for candidates who fulfill both the following criteria:
- (1) they are eligible for stage III
- (2) they also hold a Medical Degree (MBBS/ BDS/ MDS/ DNB/ MD/ MS/ DM/ M.Ch.) or M.Sc. (Nursing).

ii. Non-Medical candidates

- 10 marks will be added to the total score of Stages I and II for candidates who fulfill both the following criteria:
- (1) They are eligible for stage III
- (2) They also have qualified in any one of the following National Entrance Tests leading to the award of a fellowship tenable at AIIMS, Rishikesh in the last 2 years:
 - Joint CSIR-UGC NET for JRF
 - ICMR JRF
 - ICMR- SRF
 - •DBT JRF
 - NBHM screening test
 - INSPIRE fellowship
- Such candidates should apply under the Own Fellowship (OF) category and attach proof of award of the qualifying fellowship in the form. The fellowships should be tenable at AIIMS, Rishikesh
- To be eligible for special weightage marks, ALL the following criteria must be fulfilled:
- 1. The result of the above listed National Entrance Tests must have been declared between January 2024 and last date of application).
- 2. The award of the fellowship must be based on the result of the above listed National Entrance Tests
- 3. The fellowships should be tenable at AIIMS, Rishikesh
- 4. The letter of award of fellowship must be sent with the application form. Passing of the listed National Entrance Tests is not acceptable as proof of award of fellowship.

- C. <u>Stage III</u>: Three (03) times as many eligible candidates as the number of seats advertised in a department will be called for departmental clinical/practical/lab based assessment/Departmental assessment & interaction with IRRB (carrying 20 marks). These marks will be added to the marks of stages I + II + special weightage to determine the final total marks. In-service medical candidates of AIIMS Rishikesh will be exempted from appearing in stage I & II, they will appear directly for stage III.
- D. <u>Final Result:</u> Candidates who secure 50% marks in Stage-I, II, special weightage & Stage III

 Combined (50/100) shall be eligible for admission and shall be included in the final merit list. If a candidate is awarded special weightage marks based on submitted documents that are subsequently found to be ineligible, the special weightage marks awarded will be withdrawn and the final result will be recalculated.

Final result of qualified candidates will be prepared based on number of seats available. Final result of selected candidates will only be declared after getting approval from Executive Director, AIIMS Rishikesh. Selected candidates are required to join within last date of joining as mentioned in result information uploaded on Institute website. In case a candidate fails to join by this date and no written request for extension is received, it will be assumed that he/she does not intend to join course and seat will be offered to next candidate on waiting list. No further correspondence will be entertained in this regard.

Note:

- i. Result will be available on website of AIIMS Rishikesh. No individual intimation will be communicated to the candidate.
- ii. Candidates who fail to attend any of the stage of examination as mentioned above will NOT be eligible for admission
- E. <u>Method of Resolving Tie</u>: The tie cases will be resolved according to age (Date of birth), the older candidate shall get preference over the younger one.

VI. INDEMNITY BOND:

All Candidates enrolled for PhD Course shall sign a bond for completion of course. Leaving course in mid-way will involve recovery of salary/fellowship and a fine up to Rs 2 lakh based on decision of IRRB. However, candidate can request Director AIIMS Rishikesh for review of decision of IRRB.

VII. JOINING:

Selected candidates are required to join <u>as per the date given in his/her provisional offer letter</u>. In case the candidate is not granted an extension for joining and fails to join by the date given to him/her in provisional offer letter, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list. No further correspondence will be entertained in this regard.

Important: The PhD seats shall lapse if the selected candidates do not join by **25 February 2026** for January session.

VIII. ALLOCATION OF GUIDE:

Candidate shall work under supervision of a recognized Ph.D. guide of AIIMS Rishikesh based on the option chosen by the candidate at the time of application. Only a full-time regular Faculty/Director of AIIMS Rishikesh can act as a supervisor. Co-Guide can be allowed in inter-disciplinary areas from other departments of AIIMS Rishikesh or from other related Institutions with approval of DRC.

IX. IMPORTANT INSTRUCTIONS FOR FILLING UP APPLICATION FORM:

- For applying for admission to PhD Course each candidate is required to submit hard copy of signed application form provided on the website to *Dean (Exam), AIIMS, Rishikesh, Veerbhadra Marg, Rishikesh* 249203 through registered post/ speed post. The envelope should be super scribed as "APPLICATION FORM FOR PHD ADMISSION JANUARY 2026."
- 2. No candidate should register more than one application.
- 3. Candidate should fill application taking utmost care. Incorrectly, filled form may lead to rejection. It will be the responsibility of the candidates to ensure that correct details are filled. The Institute will not be responsible for any incorrect information/cancellation of candidature/loss or lack of communication etc. due to incorrectly filled Application form. Applicants must fill all the fields carefully since after submission of application request for change in any information at any later stage will NOT be considered. Candidates should keep a copy of the form for future reference till the completion of admission process.
- 4. The fee for entrance examination is non-refundable and no correspondence in this regard will be entertained. The candidate is required to go through the Prospectus carefully and acquaint himself/herself with all requirements with regard to ELIGIBILITY CRITERIA of filling of the application form. Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE.
- 5. Payment of fee: Candidates can pay the application fee through NEFT or direct bank transfer. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne by the candidate.
- 6. Candidates are advised to take a print of the payment receipt where they can see transaction number or UTR number, the receipt to be attached with the application also. Communication regarding exam will be sent on the email of candidate (as provided in the application form) well in advance of the date of examination.
- 7. Payment of application fees by any other mode viz Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will NOT be accepted. Such applications will be summarily rejected. The decision of Director, AIIMS Rishikesh in this regard shall be final and binding.
- 8. APPLICATION FEE AND MODE OF PAYMENT:
 - General/OBC Category: Rs. 2000/- + Transaction Charges as applicable.
 - SC/ST/EWS Category: Rs. 1600/- + Transaction Charges as applicable.

- PWBD Candidates are exempted from any Fee.
- 9. For all purposes, for candidate applying under SC/ST/OBC(NCL)/EWS/ & PWBD category, the candidate must possess a valid certificate issued by competent authority (as applicable to the category in format provided by AIIMS Rishikesh).
- 10. OBC Caste Certificate to be produced during 28.01.2025 to 27.01.2026 (as per format attached). An EWS Certificate issued in prescribed format for employment in Central Govt. on the basis of income of Financial Year 2024-25 issued after 01.04.2025 but not later than 27.01.2025 valid for the year 2025-26 will be considered valid. X. PROCEDURE FOR REDRESSAL OF DISCREPANCY NOTICED:

- (i) The candidates are required to verify their eligibility criteria for the project that they have applied for, before applying for the course.
- (ii) Fees deposited will NOT be reimbursed under any circumstances.
- (iii) All applicants are required to ensure that Photo and Signature is submitted. Failure to do so may result in rejection of applications. Duplicate applications from any applicant will result in cancellation of all such applications. No intimation regarding such summary rejections will be provided.
- (iv) It will be the responsibility of the candidate to ensure that correct address, Mobile No. & email ID in the Application Form is filled. AIIMS Rishikesh shall not be responsible for any miscommunication due to incorrect address, Mobile No. and email ID given by the applicant on the Application Form or non-receipt for any communication.
