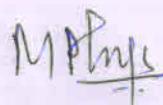

(iii)	Certificate for Person with Disabilities/ Physically handicapped [The certificate will be rejected if the disability is less than 40%].
(iv)	Class X (High School) Board Certificate as proof of Date of Birth
(v)	Matriculation (10th) Marks Sheet
(vi)	Intermediate (12th) Marks Sheet
(vii)	Intermediate (12th) Certificate
(viii)	Qualifying Examination Marks Sheet/ Grade Card: (Strike out whichever is not applicable) a. B. Tech/ B.E./ B. Arch. Or equivalent b. M.Tech/M.E/M.Arch/MURP or equivalent

(xi)	Undertaking on stamp paper of Rs. 100/- or more regarding refund of stipend
(xii)	Affidavit for disciplinary rules regarding Ganga riverside on stamp paper of Rs. 100/- or more
(xiii)	Medical Certificate issued from the registered Medical Practitioners/ Govt. Doctors
