# **CENTRALISED ALLOTMENT TO PHARMACY COURSE-2025**

The activities related to the second phase allotment to Pharmacy course for the year 2025 has commenced

**Option Confirmation is mandatory**:- Candidates who got allotment and remitted the required fee and the candidates who have not got any allotment in the first phase shall have to make online option confirmation if they want their higher order options in Pharmacy course to be considered in the second phase of allotment. For this, candidates shall have to log into their Home Page in the website **www.cee.kerala.gov.in** and confirm their options by clicking the **'confirm'** button available therein.

After Online Option Confirmation, the candidates can re-arrange their higher order options or delete the unwanted options and also register fresh options to the newly added colleges up to 2.09.2025, 6.00 PM, through the website www.cee.kerala.gov.in. Candidates can register options in the newly included Pharmacy colleges given in the Annexure. Those candidates who have not registered options in the first phase allotment can register options to the newly included Pharmacy colleges, but Option Registration fee prescribed in the notification dated 18.08.2025 will be applicable to them.
