## **KEAM-2025 ADMISSION TO MBBS/BDS COURSES** THIRD PHASE ALLOTMENT LIST PUBLISHED

The third phase allotment to MBBS/BDS Courses to the State quota seats in Government and Private Self-financing colleges in the state of Kerala for the academic year 2025-26 is published in the website of Commissioner for Entrance Examinations www.cee.kerala.gov.in. The allotment has been published after weeding out AIQ Joined candidates and after addressing the valid complaints received against the provisional allotment list published on 30.10.2025.

The allotted candidates can take printout of the allotment memo from the candidate portal. The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. is be available on the home page of the candidate as well as in the Allotment Memo. Candidates who receive an allotment should remit the fees as shown in the allotment memo and should join the Course/College from **04.11.2025 to 08.11.2025, 4.00 PM**. If the fee already paid to the CEE in the previous allotment is higher than the fees of this allotment, the excess amount will be refunded after the closure of the Centralized Allotment Process for all the courses.

Candidates who receive an allotment afresh should remit the fee to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo on or before the date given above and should join the course/college allotted within the time specified with all the documents mentioned in the allotment memo and as per Prospectus clause 11.7.1.

Candidates allotted under SC/ST/OEC/Fishermen category and those having benefits as per G.O((MS)25/2005/SCSTDD, dated: 20.06.2005 and G.O(MS)10/2014/BCDD, dated 23.05.2014, and those candidates from Sreechitra Home, Juvenile Home, Nirbhaya Home are exempted from paying fee. However, if such candidates are allotted under Minority/NRI quota seats in Self-Financing Medical/Dental colleges, they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu 'Data Sheet' available in the home page of the candidate. The printout of this Data Sheet is to be produced before the college authorities at the time of admission. Those candidates who have an allotment should join the course/college as per the allotment before 4.00 PM on 08.11.2025.

Those candidates who do not join the course/college allotted within the stipulated time will lose their allotment as well as all the existing higher options in the stream to which the allotment belongs. Liquidated damages will also be applicable as per KEAM 2025 Prospectus clause 12.2.4(a)(ii). If any vacancy exists in MBBS/BDS courses after the third phase allotment, it will be filled up through Stray Vacancy Allotment considering the options registered afresh for the stray vacancy allotment. The category claims of those candidates who have been provisionally allotted as per interim court orders or due to pending verification of KIRTADS are subjected to final judgment of honourable court /final verification result of KIRTADS.

## **Stray Vacancy Allotment for MBBS & BDS Courses**

- There will be fresh option registration for stray vacancy allotment.
- Candidates who joined the allotted seat in the third phase allotment or who are continuing in admission are not eligible for participating in the stray vacancy allotment.
- Candidates who have been allotted seats in the third phase are not eligible for participating in the stray vacancy allotment.
- Candidates who exited the seat after 28.10.2025, 5.00 PM are not eligible for participating in the stray vacancy allotment.
- Candidates joined/holding a seat in the All India quota at the time of

stray vacancy allotment as per the data shared by the central authorities are not eligible for participating in the stray vacancy allotment.
