Offline On-Campus Counselling: 2025-26 Detailed Guidelines for Admission to B.Tech. Programs at HBTU, Kanpur

Counselling Date: August 12 [Tuesday], 2025

Reporting Time: 9:00AM

Venue: Radhakrishnan Auditorium, East Campus, HBTU, Kanpur

- 1. Applications for admission to various B.Tech. programs at HBTU, Kanpur through Offline On-Campus Counselling are invited for the session 2025-26 against vacant seats through Online Registration using link: https://erp.hbtu.ac.in/Btech.aspx.
- 2. Candidates are advised to read this guideline carefully, check their eligibility and applicable category etc. before filling and submitting the Online Registration Form.
- 3. Seats in Offline Counselling are **displayed in Table 1 (Page 4).** Candidates can apply as *per relevant category*.
- 4. Seat allotment in Offline counselling will be on the basis of merit of **JEE (Mains)** 2025 with following criteria:
 - a) Seats will be allotted on merit using Combined Rank List (CRL Rank) of JEE (Mains)-2025.
 - b) However, other state seats (All India seats) are meant for candidates belonging to other states **only**.
 - c) For seat allotment candidates <u>has to be present in person</u> else his / her candidature will not be considered.
 - d) The candidates already <u>got admitted</u> through earlier rounds of Phase-I and Phase-II Counselling and <u>have not Withdrawn</u> are <u>NOT ALLOWED</u> to participate in Offline-on campus Counselling.

Academic Eligibility-

e) The candidate must have clearly passed (10 + 2) qualifying examination from U.P. Board or its equivalent from any other recognized Board / University with a minimum of five subjects in which Physics and Mathematics are compulsory subjects along with one of the subjects from Chemistry / Bio-technology / Biology / Computer Science as Technical Vocational subjects. Candidates must obtain at least 55% marks (50% for SC / ST / OBC-NCL / Persons with Disability (PwD) candidates) in aggregate in above three subjects. In addition, all other eligibility conditions for appearing in JEE (Mains) -2025 Examination shall be applicable to the candidates.

Domicile requirement-

f) For home state seats, a Candidate who is a **domicile of Uttar Pradesh**, i.e. he / she has passed the 10+2 qualifying examination from Institution located in U.P. is eligible for counselling.

For home state seats, candidate who has passed qualifying examination from outside U.P., but his / her parents (Mother or Father) is / are Permanent Residence of U.P. is also eligible for admission. In such case, the candidate is required to submit Permanent Residence Certificate of U.P. issued in the name of his / her parents only (Father or Mother) on or after 1st April 2025.

- g) The admission in several branches, only those candidates who have All India Rank (CRL) better than the rank of the last admitted candidate (cut off list is shown in Table 1, displayed separately) through Online Counselling in the relevant reserved category i.e. SC, ST, OBC-NCL, EWS and General Category will be considered for seat allotment
- 5. Candidates appearing for Offline counselling must ensure all the relevant certificates related to their Academic qualification, Domicile and Reservation category (as per the copy of certificates enclosed) in original and 1 photocopy of each be ready and has to be produced at the time of document verification at HBTU, Kanpur on 12/08/2025. No relaxation will be given. For candidates of reserved category applying for All India/other state seats, require to submit the reservation certificates issued by Central Government.
- 6. Accepting admission in HBTU Kanpur implies the acceptance by the candidate and his / her parents or guardians of all the terms and conditions laid down by the University. Any change in the rules, regulations, fee and other specific conditions etc. of the University shall apply mutatis mutandis to the admitted candidates.
- 7. If any document / declaration submitted by the candidate is found to be false at any stage, his / her admission will be cancelled and he / she may be liable for prosecution under the law. In case of any legal dispute, the jurisdiction will be limited to Kanpur Court only.
- 8. The candidates must ensure their eligibility for admission to B.Tech. programs at HBTU Kanpur while applying. University will not be responsible for any error of judgement on the part of the candidate.

9. Offline Counselling Procedure

Tentative schedule of Offline Counselling, Procedure & Fee Deposition details are given below:

- a) The candidates are required to register using following link:
 - Registration link: https://erp.hbtu.ac.in/Btech.aspx
- b) At the end of Registration, the candidate has to deposit **Online Registration Fee** of Rs. 2500=00 (non-refundable) during 5 August [Tuesday]- 10 Aug., 2025 (Sunday, 11:59pm) on:

(Note: The candidates already paid the registration fee during first two phases of online counselling and are eligible for spot counselling, need not to pay again, however they have to register themselves and submit the old fee receipt.)

- c) Report at 9:00 AM at Radhakrishnan Auditorium, HBTU, Kanpur on August 12, 2025 as written above. Follow all the instructions as given page no. 6
- d) Candidates have to bring all listed documents in original and one set of self attested photocopy for verification on during Offline Counselling, (refer Page 9).
- e) In case of Document Verification, followed by seat allotment the candidate <u>has to submit full Academic Fee of Rs. 1,35,000/- . through **Online or Cash or Demand Draft** in favour of **Finance Controller, HBTU, Kanpur** payable at **Kanpur** at the specified counter in the University premises.</u>
- 10. In case, Board / University awards only letter grades for qualifying examination without providing an equivalent percentage of marks, the candidate should obtain a certificate from the Board / University specifying equivalent marks.
- 11. The allotment of seats through counselling will be carried out strictly on merit in accordance with the JEE (Main) 2025 rank of the candidate.
- 12. There are few branches in which there is a rider on CRL rank as mentioned at Point 4(g) & in Table 1.
- 13. All the information in connection with B. Tech. Admission 2025 shall be made available through the admission website: http://www.hbtu.ac.in. The candidates are advised to visit these websites regularly. University will not be responsible for any loss to candidate due to the lack of communication.

14. Medical Standards

- **a)** Candidates will have to submit a certificate of Medical Fitness / Handicapped on Certificate no. 8.
- **b)** The medical standards prescribed are given below:
