## Subject: Physical Verification Schedule for PET-Exempted Candidates for Ph.D. Admission.

It is hereby informed that the Bhakta Kavi Narsinh Mehta University is planning to organize the Physical Verification Process for PET-Exempted Candidates only for the purpose of finalizing merit and preparing the overall evaluation outcome. This verification is applicable only to candidates who are exempted from PET and hold qualifying credentials such as UGC/CSIR (JRF), NET, NET for Ph.D., SLET, GSET, or equivalent recognized examinations.

The verification will be conducted across 22 subjects. The Document Verification Schedule is attached herewith for reference. The evaluation of PET-Exempted candidates will be carried out as per the approved merit calculation structure.

### **Assessment Structure for PET-Exempted Candidates**

Total weightage for PET-exempted applicants shall be 70% based on Academic Performance as detailed below, while the remaining 30% shall be evaluated by the Research Advisory Committee for Admissions (RAC).

Criteria	Marks Distribution
1. Undergraduate (UG) Score – 10% of obtained percentage	10 Marks
2. Postgraduate (PG) Score – 20% of obtained percentage	20 Marks
3. M.Phil. Completion	15 Marks
4. JRF: 15 Marks, NET: 10 Marks, SLET: 08 Marks	15 Marks
5. Teaching Experience – 1 mark per completed year (Maximum 10 marks, only for University recognized teachers after JRF, NET, SLET)	
Total Academic Marks	70 Marks

All candidates are instructed to remain present with original documents and photocopies as per the schedule attached. The RAC evaluation will further contribute 30% weightage toward the final merit preparation for both PET and PET-exempted candidates.
