Supporting-Document Checklist

Document	Why it is attached
Bank statements, 3 to 6 months	Shows stable liquid funds, no sudden deposits
Fixed deposit receipts	Adds committed savings to the liquid picture
Income tax returns, 2 to 3 years	Proves the income line stated in the affidavit
Salary slips or business proof	Connects income to its source
CA net-worth certificate (where asked)	Consolidates assets in one certified figure
Education loan sanction letter (if any)	Counts as committed funding alongside savings
Sponsor ID proof	Matches the deponent to the documents

Rules that keep it credible

- Numbers in the affidavit must match the annexed statements to the rupee.
- Use the exact program and university name from the admission letter.
- Keep it dated within about 6 months of the application or visa filing.
- For the USA, universities may ask for their own form or USCIS Form I-134 instead. Follow what the checklist names.
- Germany largely uses the blocked account, or a formal obligation letter (Verpflichtungserklärung) given at the local foreigners office, not this affidavit.
