1. INTRODUCTION

AIIMS Bhopal is one of the apex healthcare institutes being established by the Ministry of Health & Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY), to correct regional imbalances in quality tertiary-level healthcare in the country, and attaining self-sufficiency in Graduate and Postgraduate medical education and training.

This Institute was established by an Act of Parliament on lines of the original All India Institute of Medical Sciences in New Delhi which imparts both undergraduate and postgraduate medical education in all its branches and related fields, along with Nursing and Paramedical training to bring together in one place educational facilities of the highest order for the training of personnel in all branches of health care activity.

Mission Statement

To establish a center of excellence in medical education, training, health care and research imbued with scientific culture, compassion for the sick and commitment to serve the underserved.

- *Inadequately filled or incomplete applications will be rejected.*

5. General Eligibility

Eligibility for Ph.D. course: A candidate seeking admission to the course of study leading to the award of a Degree of Doctorate of Philosophy must possess at least one of the following qualifications:

- Medical Qualification: MBBS/BDS/MD/MS/MDS/DM/M. Ch/BAMS/BYMS/BHMS/DNB in the subject concerned. Candidates who have obtained any of these degrees from medical colleges which are not recognized by the Medical Council of India/Dental Council of India/Nursing Council of India/National Medical Commission shall not be eligible to apply.
- **Nursing Qualification:** Candidates with M.Sc. Nursing qualification recognized by Indian Nursing Council can apply.

Non- Medical Qualification:

- A. **Life Sciences**: eligibility shall be Master's Degree (two years course) awarded by Indian Universities or equivalent in the subject
- B. Non- Life Sciences: Candidates with qualification in non-life sciences subject (M.Sc., M. Pharma, B. Tech, M.A.(Psychology) and M.A. in Social work (Social Sciences) can apply
- Candidate possessing Master's Degree through distant learning course shall not be eligible.
- Candidate should have at least 55% marks in the last eligibility examination qualified.
- Candidates working under Central Govt./Semi Govt./Autonomous organization should submit their applications through proper channel i.e., employer. They will be required to submit a "No Objection Certificate" from their employer along with the application form before they are allowed to appear for the selection process of the Ph.D. Courses.
- The candidates, must have completed the requisite qualification and degree **on or before closing date of application.**
- Applicants from AIIMS Faculty/Scientific Staff will be considered in-service candidates for Ph.D. registration per guidelines laid down by AIIMS Bhopal in this regard.

Requirements for Admission of Foreign Nationals (SAARC Applicants)

- 1. Sponsorship certificate in the format prescribed in the Prospectus, duly completed and signed by the competent authority.
- 2. NOC from Ministry of Health & Family Welfare in case of Foreign Nationals.
- 3. The foreign nationals are required to send their registration form of application through Diplomatic Channel. They are also required to appear in the Interview along with other candidates. An 'Advance Copy' to be submitted at AIIMS, Bhopal (Email id: registraroffice@aiimsbhopal.edu.in) before the last date of registration. However, the application of all such candidates will be processed only after receipt of the same through Diplomatic channel.

4. No emoluments will be paid by AIIMS Bhopal to the Foreign National candidates.

6. Duration of the Course

- I) The duration of the course shall be the time period from registration to submission of thesis. The minimum period of registration in respect of all the candidates who are registered for Ph.D. shall be three years. The maximum period of registration shall not exceed five years. Extension beyond the period of 5 years can be given for a maximum period of 6 months on the recommendation of Dean (Academics) with approval of the Executive Director.
- II) Further extension of six months beyond 5 ½ years can only be given by the Academic Committee for a maximum period of 6 months in highly exceptional circumstances (like medical exigencies, natural calamities etc.) and such extension may not be given retrospectively.
- III) The Chief Guide of Ph.D. Student shall give clear reason for the delay to the Doctoral Committee.
- IV) In case of extension beyond 5 ½ years without justifiable reasons and circumstances as mentioned above, the Ph.D. registration of the candidate shall be cancelled.
- V) Failure to submit thesis within stipulated time period of maximum 5yrs. with extension after approval up to 5½ years (6 years in exceptional circumstances by prior approval of Doctoral Committee) shall lead to cancellation of Ph.D. registration of the candidate.

7. Method of Selection for category (A) applicants

- Stage I (Written Exam):
 - **A)** Covering topics: Health Sciences, Life Sciences, General Knowledge, Aptitude and Research Methodology

B) Marking Scheme:

- 1) Each correct answer (MCQ) will be awarded one mark
- 2) More than one answers for a question will be treated as a wrong answer and will not be awarded by any mark
- 3) No mark will be given to question(s)if it is unanswered/ Unattempt/marked for review
- 4) Overlapping answer/marking extending to another answer will be also considered zero
- 5) There is no negative marking

<u>Candidates must score at least 50 percent (40 Marks) in Stage-I to be eligible</u> for Interview.

• Final merit will be made based on the cumulative marks obtained in the stage I + Interview and the result of stage-I will be available on the website of AIIMS Bhopal and notice Board.

If any discrepancy in any question is found in the Entrance Examination, the candidates advised to write to Dean (Examination), AIIMS, Bhopal – 462020 within 24 hours on the following email: Email dean.exam@aiimsbhopal.edu.in. This mail will only be used for discrepancy related to questions. However, for other queries please mail on registrar@aiimsbhopal.edu.in.

Note:

- *I)* Any seat may be withdrawn at any given point of time on the recommendation of the competent authority.
- *II*) All candidates declared eligible for appearing in Interview will be called as per schedule displayed on the website.

8. Rules for admission for in-service candidates applicable for AIIMS Employees/other govt. institute-sponsored candidates.

- In-service faculty members and scientists from Govt. Institutes would also be awarded PhD admission, subject to fulfilment of rules and regulations of the respective institute.
- Candidates with their own fellowship and in-service faculty members and scientists can
 be exempted from the written test and can be directly called for evaluation during the
 Interview.
- All in-service/sponsored candidates should route the application through proper channel with NOC from the competent authority of the institute.
- It is mandatory to In-service candidates from AIIMS Bhopal to take study/any other leave for a continuous period of one year at any time during the PhD programme as per entitlement under the CCS rules.

9. Leaves and other rules

The Ph.D. students are entitled to 30 days of leave every year. If leave availed exceeds the limit within a year, then the extended period is treated as extraordinary Leave and his/her registration period will be extended for the same duration. However, extraordinary leave cannot be more than 3 months in the entire registration period of 5 years. Any such extension beyond 3 months shall lead to the registration being cancelled. The female candidates shall be entitled for maternity leave etc as per existing rules. In case the Chief Guide recommends a candidate for specific training or project-related work outside AIIMS Bhopal (within India or abroad), the leaves shall be treated as on-duty/Study leave. This study leave shall not be more than 6 months in the entire registration period. The proof of acceptance of the candidate for such training/work outside should be submitted and on return, the report of such training/work done shall be required to be submitted to the Dean, by the candidate through the Chief Guide.

10. Submission of application by candidates who are Employed

The candidates in employment applying for Ph.D. programme are required to submit their applications through proper channel. They should also sign the undertaking in the downloaded copy of Registration Form that they have informed their employer about the submission of the application to AIIMS Bhopal. If any communication is received from their department/office withholding permission to the candidate's appearing at the entrance examination/admission to the course, the candidature/admission of the candidate will be cancelled.

11. Requirements for admission of "sponsored" candidates

- a) Candidates who are permanent employees of any Central/State Government/Armed Forces or the Public Sector Undertaking/Autonomous Body can be sponsored by the respective Government/Defence Authorities or the Competent Authorities of PSU/Autonomous Body.
- **b**) The Department for which the candidate is being sponsored should be clearly specified in the sponsorship form by the sponsoring authority. The candidate can be sponsored for only one department. The applications of those candidates who are sponsored for more than one department will not be considered.

- c) "Sponsored" candidate will not be paid any emoluments by the Institute during the training period. Such payments will be the responsibility of the sponsoring authority (i.e. Central/State Government or Defence Authorities).
- d) Sponsored candidates must submit/send a **sponsorship certificate in original to the Office of Registrar** from their employers in the prescribed format along with the application form. Those who fail to do so should submit it before the date of the entrance Exam, failing which their candidature will be cancelled.
- e) It is mandatory to be a full-time research Scholar during the first year of Ph.D. program by availing Study/any other leave for a continuous period of one year for the Sponsored candidate registering for Ph.D. program at AIIMS Bhopal.

12. Submission of caste/category certificate by SC/ST/OBC/EWS/PWBD candidates

After the declaration of the result of the Entrance Examination, candidates belonging to Scheduled Caste/Scheduled Tribe, Other Backward Classes, Economically Weaker Section and PWBD should submit an attested copy of a certificate from any one of the following authorities stating that the candidate belongs to Scheduled Caste, Scheduled Tribe or Other Backward Classes, Economically Weaker Section and PwBD in the prescribed form

- **A.** District Magistrate, Additional District Magistrate, Collector, Deputy Commissioner, Additional Deputy Commissioner, Deputy Collector, 1st Class Stipendiary Magistrate, City Magistrate, Sub-Divisional Magistrate, Taluka Magistrate, Executive Magistrate, Extra Assistant Commissioner
- **B.** Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate.
- C. Revenue Officer not below the rank of Tehsildar.
- **D.** Sub-Divisional Officer of the area where the candidate and his or her family normally reside. Administrator/Secretary to Administrator/Development Officer (Lakshadweep Island) or as authorized in the Constitution.

The candidate will be required to submit an undertaking to the effect of their caste. The detection of any discrepancy in the caste certificate shall entail cancellation of registration. This is as per the provisions made by the Ministry of Personnel, Public Grievances and Pensions vide their order No. 36033/4/97-Estt. (RES) dated 25.7.2003 and No. 36011/3/2005-Estt. (RES) dated 9.9.2005 respectively.

Candidates must note that a certificate from any other person/authority, as mentioned above will not be accepted and no further correspondence in this regard shall be entertained. The name, designation and the seal of the Officer should be legible on the certificate.

13. Course Fees

- Fees and other charges once paid shall not be refunded in any case and no correspondence will be entertained in this connection. However, the caution money will be refunded to those candidates who do not join the course. The caution money must be claimed within one year after completion of the course failing which it will be forfeited.
- **14. Hostel Accommodation:** Subject to availability (If hostel is allotted then Rs.1080/- as hostel rent has to be paid by the candidate)

15. Provision for penalty

Category A candidates: If any candidate joins the Ph.D. program and leaves the said course during the stipulated time, he/she shall be liable to pay a sum of Rs. 2,00,000/- (Rupees two lakhs) or the amount of stipend/salary paid till the date of resignation, whichever is higher for the losses incurred by the AIIMS/Project due to such midterm departure. The stipend/Salary for the month in which her/his resignation from the PhD seat becomes effective shall also stand forfeited. However, any relaxation as requested by the candidate may be considered by the Competent Authority if deemed appropriate.

Category B candidates: No penalty

16. Code of conduct for Ph.D. students at AIIMS, Bhopal

(i) Maintenance of Discipline among Ph.D. students:

- **1.** All powers relating to discipline and disciplinary action are vested with the Director, AIIMS, Bhopal.
- 2. The Director, AIIMS may delegate all such powers, as he/she deems proper to the Dean (Academics) and to such other persons as he/she may specify on his behalf without prejudice to the generality of power to enforce discipline under the Rules.
- **3.** The following shall amount to acts of gross indiscipline:
- Physical assault or threat to use physical force against any member of the teaching or nonteaching staff of any Department/Centre of AIIMS or any other persons within the

- premises/ Campus of AIIMS. Carrying or use or threat of use of any weapon.
- Violation of the status, dignity, and honour of students belonging to the Scheduled Castes, Scheduled Tribes, Other Backward Castes, and PwBD.
- Any practice, whether verbal or otherwise, derogatory to women
- Any attempt of bribing or corruption in any manner
- Willful destruction of institutional property
- Creating ill-will or intolerance on religious or communal grounds
- Disrupting in any manner of the functioning of the AIIMS, Bhopal
- Regarding ragging the directive of the Supreme Court will be followed strictly. It is as under: "As per direction of the Hon'ble Supreme Court of India, the Government has banned ragging completely in any form inside and outside of the campus and the Institute authorities are determined not to allow any form of the ragging. Whoever directly or indirectly commits, participates in abets or instigates ragging within or outside any educational Institution, shall be suspended, expelled or rusticated from the Institution and shall also be liable to a fine which may extend to Rs. 10,000/-. The punishment may also include cancellation of admission suspension from attending the classes, withholding/withdrawing fellowship/ scholarship and other financial benefits, and withholding or cancelling the result. The decision shall be taken by the Head of the Institution."
- **4.** Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate. The Director, may in the exercise of his/her powers aforesaid order or direct that any student or students:
- Be expelled
- Be or be not for a stated period, admitted to a course or courses of study at AIIMS Bhopal
- Be fined with a sum of rupees that may be specified
- Be debarred from taking any examination(s) for one or more semesters
- Withhold the result of the concerned student(s) in the Examination(s) in which he/she or they have appeared to be cancelled
- Be prohibited from appearing or completing any examination for any unfair means like copying, taking notes, mobiles or any other electronic gadgets inside the examination halls
- **5.** At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Director and several authorities of the AIIMS who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Rules that have been framed there under by competent authorities.

(ii) Prohibition of and Punishment for Ragging:

- **1.** Ragging in any form is strictly prohibited, within the premises of the College/Department of Institution and any part of AIIMS and also outside the AIIMS Campus.
- 2. Any individual or collective act or practice or ragging constitute gross indiscipline shall be

dealt with under these rules.

- **3.** Ragging for these rules, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are, in any way, considered junior or inferior by other students and includes individual or collective acts or practice which:
 - Involve physical assault or threat or use of physical force
 - Violate the status, dignity, and honor of women students
 - Violate the status, dignity, and honor of students belonging to the Scheduled Castes,
 Scheduled Tribes and Other Backward Castes
 - Expose students to ridicule and contempt and affect their self-esteem
 - Entail verbal abuse and aggression, indecent gestures and obscene behavior
 - The Director, Dean, Hostel Superintendent, and Faculty of AIIMS Bhopal shall take immediate action on any information of the occurrence of ragging
- **4.** Notwithstanding anything in Clause (4) above, the Dean or any other Faculty member/or authority may also *Suo-moto* enquire into any incident of ragging and make report to the Executive Director of the identity of those who have engaged and the nature of the incident.
- **5.** The Dean may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- **6.** On the receipt of a report under clause (5) or (6) or a determination by the relevant authority disclosing the occurrence or ragging incidents described under the first three points in Clause 3, the Executive Director shall direct or order rustication of a student or students for a specific number of semesters.
- 7. The Director may in other cases of ragging order or direct that any student or students be expelled or be not, for a stated period, admitted to a course of study as AIIMS, departmental examination for one or more semesters or that the result of the student or students concerned in the examination(s) in which they appeared to be cancelled.
- **8.** In a case where students who have obtained degree(s) of AIIMS are found guilty under this Rules, appropriate action will be taken for withdrawal of degrees conferred by the AIIMS.
- **9.** For this Rules, abetment to ragging will also amount to ragging.
- (iii) Internal Complaint Committee: A statutory committee, comprising of members from the teaching and non-teaching staff as well as students looks into matters related to sexual harassment of students and staff in the college. Any person aggrieved in this matter may fearlessly approach the committee for a fair and concerned hearing and redressal.
- (iv) Unauthorized absence of students: Unauthorized absence of students will be informed to the students and also Parents or Local Guardians. At least 3 reminders will be issued with a gap of 10 days by the Academic Section to these students. Thereafter the action for cancellation of the registration of the concerned will be decided by the Dean (Academics) / Director, AIIMS Bhopal.
- (v) Transferring of Research Fellowship from other institutes to AIIMS Bhopal for PhD candidates under Category B is permissible once during the entire PhD tenure.

For any interpretational variation/discrepancy in the above-mentioned Ph.D. rules/norms the decision of the Director, AIIMS Bhopal will be binding to all concerned.
