No.DHS-304(1)/4/2025-DHS-DHS: Candidates registered for Manipur Medical eCounselling 2025-26 shall compulsorily fill in "Seat Choices" in the web App <https://manipurmc.mn.gov.in> to participate in the 3<sup>rd</sup> Round of the eCounselling for allotment of (a) State Government quota seats for MBBS/BDS/BASLP/BPT courses, (b) Management quota seats for MBBS course at SAHS and (c) NRI quota seats for MBBS course at SAHS as per schedule given below:

2. NEET-UG 2025 qualified candidates who have not registered in previous rounds are allowed "to register" and fill in "Seat choices" in the web App to participate in 3<sup>rd</sup> Round of Manipur Medical eCounselling 2025-26 as per the schedules. Link to the web App is also available in this Directorate website <https://manipurhealthdirectorat.mn.gov.in>. Before registering in the web App, candidates shall carefully read the "General Instructions for Registration" and "Technical Instructions for Registration" given in this Directorate notification of even No. dated 28-07-2025 and 29-07-2025 respectively.

3. Registration will be complete after payment of the following 02(two) kinds of Fees:

a. Non-refundable Application Fees as follows:

(i) ₹ 2000/- (₹ 1500/- for ST and SC candidates) for State Government seats.

(ii) ₹ 2000/- for Management & NRI quota seats at SAHS.

(iii) ₹4000/- (₹3500/- for ST & SC candidates) for both Government and Management / NRI quota Seats.

b. Refundable Security Fees of ₹ 5000/- for all categories. This amount shall be refunded after completion of all rounds of eCounselling.

No fees shall be separately charged for "Choice Filling" in the web App.

4. Registered candidates shall carefully read the "Technical Instructions for Choice-filling" given as Annexure A before filling in "Seat Choices" in the web App.

5. Merit list of candidates for the 3<sup>rd</sup> Round of eCounselling shall be prepared from the candidates who have successfully filled in "Seat Choices" for the 3<sup>rd</sup> Round of eCounselling as above. "Choice of seat" filled in any round will not be valid for further rounds.

6. Candidates who have joined the seats allotted in previous Rounds shall be included in the Merit List for the 3<sup>rd</sup> Round only after uploading the "NOC" in the prescribed format while filling in "Seat Choices" in the web App.

7. If a candidate is allotted a new seat in the 3<sup>rd</sup> Round, the seat previously allotted to the said candidate in the previous Rounds shall be deemed to be vacant and shall be allotted to another candidate in the same Round.



8. Upgradation of seats will be allowed only up to the 3<sup>rd</sup> Round of eCounselling. If a candidate is allotted a seat (new / upgraded) in 3<sup>rd</sup> Round, he/she will not be permitted to participate in further rounds. Only those who have not been allotted any seat will be allowed to participate in any eCounsellings after 3<sup>rd</sup> Round.

9. **If a candidate does not report after getting a seat allotted in 3<sup>rd</sup> Round, he/she will be forfeited of the security deposit and will be eliminated from further rounds of eCounselling.**

10. New candidates who registered in 2<sup>nd</sup> Round, without getting opportunity to register for Management quota seats, shall be permitted to re-register for the same. However, re-registration is not permissible for candidates who had registered in 1<sup>st</sup> Round.

11. The available seats of State Government Quota in the 3<sup>rd</sup> Round of eCounselling is enclosed as Annexure B.

3rd Round of Counselling is opened for:

- 1) New Registration – For candidates who did not apply in the 1<sup>st</sup> or 2<sup>nd</sup> Round of Counselling. (Please refer to "General Instructions for Registration" and "Technical Instructions for Registration" notified vide this Directorate notification No.DHS-304(1)/4/2025-DHS-DHS dated 28-07-2025 and 29-07-2025 respectively.)
- 2) Completion of Incomplete Applications – Candidates who started the Registration process in the 1<sup>st</sup> or 2<sup>nd</sup> Round of eCounselling but did not complete the final submission.
- 3) Choice Filling for 3<sup>rd</sup> Round – For candidates who are already registered and approved, including candidates who were allotted seats in the previous Round.
